PUBLIC HEALTH

A motion was made by Graalman, seconded by Fleming and unanimously carried to enter into an agreement with the Wyoming Department of Health, Division of Preventive Medicine whereby the Carbon County Public Health Department will provide AIDS/HIV counseling, testing and educational outreach services for the state.

A motion was made by Fleming, seconded by Graalman and unanimously carried to enter into an agreement with the State of Wyoming Department of Health, Health Care Financing whereby the Carbon County Public Health department will conduct Medicaid related medical eligibility and preadmission reviews to assist the state.

EXTENSION

Candy France, representing the Fair Board and Judy Smith and Charlene Abbott of the Extension office met with the Commissioners.

EXCISE TAX

A motion was made by Fleming to pass a resolution of the governing body of the County of Carbon, Carbon County, Wyoming, authorizing the continuation of an excise tax of 1% as authorized by Wyoming Statute 39-6-412(ii) upon the retail sale of tangible personal property, admission and services made within Carbon County, Wyoming.

The motion died for lack of a second.

PLANNING

A motion was made by Fleming, seconded by Zeiger and carried to approve the following case file:

Case File #94-02 - Final Plat of Block 1, Ryan Park 4th Addition - Ryan Park Land Company, c/o Jim Wagner, Star Route Box 9K, Ryan Park, Saratoga, WY 82331. A final plat review for a proposed subdivision in Ryan Park legally described as lots 1 through 4, Block 1, Ryan Park 4th Addition in the N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 28, Township 16 North, Range 81 West, Carbon County, Wyoming, consisting of 20.9 acres of land.

A motion was made by Fleming, seconded by Zeiger and carried to approve the following case file:

Case File #94-04 - Subdivision Variance - Ryan Park Land Company, c/o Jim Wagner, Star Route Box 9K, Ryan Park, Saratoga, WY 82331. A subdivision variance to allow for some short spans of road to exceed an 8% agrade as required in Section 6.03 of the Carbon County Subdivision Regulations on land legally described as Lots 1 through 4, Block 1, Ryan Park 4th Addition. Subdivision lying in the N $\frac{1}{2}$ NW $\frac{1}{4}$ of Section 28, Township 16 North, Range 81 West, Carbon County, Wyoming.

BEST MANAGEMENT PRACTICES

A motion was made by Fleming, seconded by Zeiger and carried to adopt the following:

R E S O L U T I O N 1 9 9 4 - 1 0

A RESOLUTION ADOPTING BEST MANAGEMENT PRACTICES DESCRIBING THE DESIRED RESULTS FOR SILVICULTURE OPERATIONS AS THEY RELATE TO SOIL AND WATER RESOURCE PROTECTION AND BENEFICIAL USES; AND CONSERVATION PRACTICES FOR LIVESTOCK GRAZING AND WILDLIFE UTILIZATION ACTIVITIES TO IMPROVE WATER QUALITY ON BOTH PUBLIC AND PRIVATE LAND IN THE STATE OF WYOMING.

WHEREAS, the Carbon County Commissioners have on the 1st and 15th days of February, 1994, held public hearings regarding the documents for Silviculture Best Management Practices, Department of Environmental Quality, Wyoming Nonpoint Source Management Plan, Final Draft September 1992; and the Livestock Grazing and Wildlife Utilization BMP's developed by a subcommittee of the Wyoming Range-land Management Coordinating Committee, submitted to Dennis Hemmer, DEQ, April 30, 1990. Best Management Practices are required to be included in State Management Program Plans by Section 319 (b) (2) (a) of the Federal Clean Water Act of 1987.

WHEREAS, the Carbon County Commissioners support said plans and practices;

NOW, THEREFORE, BE IT RESOLVED BY THE CARBON COUNTY COMMISSIONERS that said Commission hereby adopts the Livestock Grazing and Wildlife Utilization BMP's and the Silviculture BMP's, and said Best Management Practices provide technical support documents with references cited. These documents are attached hereto and incorporated herein by this reference.
