A Zone Change from RAM (Ranching, Agriculture, Mining) to RD (Residential Development) to provide for the concurrence of existing development and plans with the County zoning in the Aspen Highlands Subdivision First Filing, legally described as lots 1 through 47 (excluding Lots 22 and 25 which have already been rezoned) in the NE $\frac{1}{4}$ SE $\frac{1}{4}$, NW $\frac{1}{4}$ SE $\frac{1}{4}$; NE $\frac{1}{4}$ SW $\frac{1}{4}$, SE $\frac{1}{4}$ NE $\frac{1}{4}$, SW $\frac{1}{4}$ NE $\frac{1}{4}$; SE $\frac{1}{4}$ NW $\frac{1}{4}$ of Section 10, Township 19 North, Range 81 West, Carbon County, Wyoming.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to approve Case File #94-11 as follows:

Case File #94-11 - Zone Change - Thomas S. Lankford, P.O. Box 2639, Casper, WY 82602. A Zone Change from RAM (Ranching, Agriculture, Mining) to HB (Highway Business) to allow for a highway business on land legally described as Lot 53 in the N $\frac{1}{2}$ SE $\frac{1}{4}$ NE $\frac{1}{4}$ of Section 24, Township 21 North, Range 88 West, Carbon County, Wyoming, consisting of 4.82 acres.
