#### POLICY STATEMENT

It is the policy of the Little Snake River Valley Airport Board in conjunction with Carbon County, Wyoming hereinafter referred to as the SPONSOR, that disadvantaged business enterprises (DBEs) as defined in DOT Regulation 49 CFR Part 23, as amended by Subpart D, shall be afforded the maximum opportunity to participate in the performance of contracts which are funded in whole or in part through the Airport Improvement Program (AIP) for Dixon Airport, Dixon, Wyoming.

The SPONSOR will take necessary and reasonable steps in accordance with 49 CFR Part 23 to ensure that disadvantaged business enterprises have the maximum opportunity to compete for and perform contracts and shall not enter into long-term, exclusive leases that can preclude DBE activity at the airport. The SPONSOR and its contractors shall not discriminate on the basis of race, color, age, national origin, or sex in the award and performance of DOT-assisted contracts.

This Policy Statement will be made known to all activities of Dixon Airport and to local business and community organizations, both disadvantaged and non-disadvantaged.
