SENIOR SERVICES

Buddy Ray, representing Carbon County Senior Services, Inc. introduced himself as the new executive director for that organization.

LICENSE AGREEMENT

A motion was made by Fleming, seconded by Graalman and unanimously carried to execute a license agreement between Carbon County government and Elk Mountain Ranch for non-exclusive right-of-way over an existing road for access purposes to the County's existing communications facility on Elk Mountain.

PUBLIC HEALTH

Gennevieve Luallen, director of the Carbon County Public Health program, requested permission to fill the part-time clerk position in the Best Beginnings office. The Commissioners approved the request.

Luallen also requested consideration of her need to replace the office copier. No action was taken on the copier request.

PROCLAMATION

The Commissioners signed a proclamation designating May 1, 1995 as Law Day and called upon all citizens, schools, businesses, clubs and the news media to commemorate the role of law in our lives.

ROAD & BRIDGE

County road and bridge supervisor, Don Neuman gave his administrative report.

The Commissioners signed an agreement between the Department of Transportation and the County for coldmilled plant mix of the East Sinclair Interchange.

The Commissioners signed a right-of-way easement on Carbon County Road #500.

PROCLAMATION

A motion was made by Fleming, seconded by Graalman and unanimously carried to sign a proclamation designating the week of April 23rd to April 29th, 1995 as county Crime Victims' Rights Week.

PLANNING

County planner, Nina Adams gave her annual report for 1995, and the monthly administrative report.

Henry Hewitt of the Planning Commission, discussed the cost of forming a land use plan. He estimated the cost to be \$150,000.00.

EASEMENT PETITION

Mason Skiles presented a petition for the establishment of a private road for John M. McGill. The hearing is set for 4:00 p.m. on May 1, 1995.

ROAD & BRIDGE

A motion was made by Fleming, seconded by Graalman and unanimously carried to enter into a right-of-way construction and easement agreement on the condition that the animal under passes are approved by the Department of Transportation. This agreement is between Elmer G. Peterson and Carbon County for work to be done on the Seminoe Road (County Road #351).

THE EXECUTIVE GROUP

Mechelle Schultz, representing The Executive Group, updated the Commissioners on the progress of personnel assessments.
