The Ryan Park Fire Department is requesting \$25,000.00 for a Fire House. The Commissioners wrote a letter in support of this project. They will look into matching funds for this project.

CARBON COUNTY 4-H PROGRAM

The Commissioners signed an agreement with the Carbon County 4-H Program for an Associate presently 3/4 time. This Associate would be full time for the three (3) months in the Summer, 3/4 time for the three (3) months in the Spring and Fall and 1/2 time for the three (3) months in the Winter.

The Extension Office has agreed to provide a set amount of up to \$10,000.00 plus their share of benefits. The County would pay the balance of the salary and benefits. The Extension Office would bill the County on a quarterly basis.


MEMORIAL HOSPITAL BOARD

Linda Fleming made a motion to appoint Linda Smith to the unexpired term held by Lorna Engstrom on the Memorial Hospital Board. This motion was seconded by Gary Graalman and unanimously approved.
