A RESOLUTION PROVIDING FOR THE IMPLEMENTATION OF A 911 SURCHARGE FOR THE 326 AND 327 TELEPHONE INTERCHANGES IN CARBON COUNTY, WYOMING

WHEREAS, Wyoming Statute §16-9-101, et seq., authorizes town, after public hearing, to impose a monthly surcharge upon each local access telephone line within the portions of the governing body's jurisdiction in which the enhanced 911 service is provided; and

WHEREAS, the towns of Encampment, Riverside, and Saratoga intend to provide E-911 service to their respective towns through the equipment and services provided by Union Telephone Company; and

WHEREAS, the towns of Encampment, Riverside and Saratoga intend to provide E-911 service to those areas outside of the respective towns covering the 326 and 327 telephone interchanges; and

WHEREAS, Wyoming Statute §16-9-103(b) authorizes counties to impose a monthly uniform charge in an amount not to exceed \$.50 on each local exchange access line in those portions of the county's jurisdiction for which the E-911 system is to be provided; and

WHEREAS, it is in the best interest of the county, through the Town of Saratoga, to provide such service,

NOW, THEREFORE, BE IT RESOLVED BY THE CARBON COUNTY COMMISSIONERS, CARBON COUNTY, WYOMING, that Resolution No. 1995-8

be the same is hereby adopted to read as follows:

ENHANCED 911 SURCHARGE

Section 1: The following words and phrases shall have the meaning specified in Wyoming Statute §16-9-102:

- "Governing body"
- "Local exchange access company"
- "Local exchange access line"
- "911 emergency reporting system"
- "911 system"
- "911 emergency surcharge"
- "Public agency"
- "Public safety answering point"
- "Service supplier"
- "Service user"

Section 2: TELEPHONE LINE SURCHARGE IMPOSED.

(a) It is hereby imposed on each local exchange access line per telephone customer billing within the 326 and 327 interchanges, Carbon County, Wyoming, excluding those customers within the towns of Encampment, Riverside and Saratoga's jurisdictional limits, a monthly surcharge of \$.50. Said surcharge shall not exceed \$.50 per month which is the maximum surcharge allowed by law. This surcharge is hereby imposed upon each of the first one hundred local exchange access lines per telephone customer billing and no charge shall be imposed upon more than one hundred exchange access lines or the equivalent per customer billing.

(b) Union Telephone Company shall be the service supplier and provide to those customers within the 326 and 327 interchanges, the 911 system equipment, data base, installation, maintenance and exchange services within the 326 and 327 interchange service access area.

(c) The local exchange access company shall collect the surcharge imposed in subsection (a) on behalf of Carbon County and remit such to the Town of Saratoga on behalf of Carbon County.

(d) Charges imposed under this resolution and required to be collected by the local exchange access company shall be added to and stated separately in the billings to the service users.

Section 3: SURCHARGE FUNDS

(a) All income generated by the surcharge as imposed herein shall be deposited in an account to be established by the Town of Saratoga.

(b) All income deposited from surcharges imposed herein shall be credited to Carbon County by the Town of Saratoga and said proceeds shall be accounted for annually by the Town of Saratoga to Carbon County.

(c) All income generated by the surcharge will be used for the installation, maintenance and operation of the E-911 system pursuant to Wyoming Statute §16-9-104.




