TOWN OF HANNA

Bill Kaufman, Mayor of Hanna, expressed his concerns for the Town of Hanna. He was wondering if the Medical Clinic will continue to stay open? He says Hanna needs the clinic. His other concern was the County Library in Hanna. He said there is a need to increase use of the library, improve the visability, reduce current utilities, and reduce vandalism.

NORTH OF HANNA GRAVELING PROJECT

Carbon County Road 291, Hanna to Natrona County Road is currently scheduled to go to bid sometime in February or March. This project will start at Casey Palm's North Ranch and go approximately 20 miles, to the Continental Divide, up by the Red Hills. Current estimate of gravel is 800,000 cubic yards, to be placed at a six inch lift. The Road and Bridge Department still has scheduled work to do on road widening, culvert extensions and cattleguards. This work is going to start as soon as weather permits this spring.

WYOMING COMMUNITY DEVELOPMENT BLOCK GRANT CONTRACT

Gary Graalman made a motion to sign a contract between the Department of Commerce, Division of Economic and Community Development (DOC-DECD) and Carbon County. This agreement is for a Block Grant in the amount of \$41,000.00 for the Saratoga Head Start Center. This motion was seconded by Linda Fleming and unanimously approved.


CARBON COUNTY DRUG AND ALCOHOL POLICY

Linda Fleming made a motion to have a Drug and Alcohol Policy for County Employees who are required to have a Commercial Driver's License (CDL). The effective date on this policy is January 1, 1996. This motion was seconded by Gary Graalman and unanimously approved.
