Don Hodgkiss and Tim Brown met with the Commissioners to discuss a federal royalty rate reduction.

PLANNING

A public hearing was held at 2:00 p.m. regarding Case File #94-12.

A motion was made by Graalman, seconded by Fleming and unanimously carried to approve the zone change as follows:

culture, Mining) to RD (Residential Development) to allow for the con-
currence of existing development and plans with the County zoning in the
Mountain View Estates Subdivision legally described as Lots 1 - 12, Block
1; Lots 1 - 24, Block 2; Lots 1 - 12, Block 3: in the SW¼ of Section
31, Township 18 North, Range 83 West, Carbon County, Wyoming.
