
A motion was made by Graalman, seconded by Fleming and unanimously carried to accept Don Neuman's letter of resignation effective December 6, 1996.

RAWLINS/CARBON COUNTY AIRPORT BOARD


The Commissioners adjourned to the Rawlins/Carbon County Airport.
