MEMORIAL HOSPITAL OF CARBON COUNTY

Dan Baxter & Todd Bishop of Kaiser and Company, updated the Commissioners on the \$1,000,000 revenue bond issue. The closing on issuance of the bonds is scheduled for May 13th at 9:00 a.m. A motion was made by Fleming, seconded by Graalman, and unanimously carried to adopt a resolution to issue the bonds as follows:

R E S O L U T I O N 1997 - 4

A RESOLUTION AUTHORIZING THE ISSUANCE BY CARBON COUNTY, WYOMING, OF HOSPITAL REVENUE BONDS, SERIES 1997, IN THE AGGREGATE PRINCIPAL AMOUNT OF \$1,100,000.00 FOR THE PURPOSE OF CONSTRUCTING, FURNISHING AND EQUIPPING A NEW EMERGENCY DEPARTMENT, VISITING PHYSICIAN'S CLINIC AND OUT-PATIENT SURGICAL CENTER AT THE MEMORIAL HOSPITAL OF CARBON COUNTY, WYOMING.

CAPITAL FACILITIES TAX

The Capital Facilities Tax Committee requested an election date of November 4, 1997 and presented a letter identifying projects for the various towns to be financed by the tax. A date of August 26, 1997 was established as a deadline for submission of resolutions from the towns to the County Clerk for the election. The expenses of the election and consultants would be paid by the capital facilities tax if the tax is approved. If the tax is not approved, Carbon County would be responsible for the election and consultant expenses. If successful, the collection of the tax would begin January 1, 1998 with revenue to be distributed in two or three months. Up front construction financing for projects that need to begin before collection and distribution starts, would be funded by tax exempt bonds issued through a joint powers board yet to be formed.

Margaret Brown, speaking on behalf of the Old Pen Joint Powers Board, made a presentation requesting the Old Pen be part of Carbon County Government's sponsored project. The Old Pen Board requested \$300,000 to do roof repairs. Speaking in support of the Old Pen request were Richard Chenoweth, Dr. Bauman, Nina Adams, Mary Kay Maxim, and Cathy Higham.

A motion was made by Graalman, seconded by Fleming, and unanimously carried to enter into an agreement with Kaiser and Company for coordination of the 1% capital facilities sales and use tax election, organizing the sale of bonds and obtaining State grant or loan assistance where applicable.

RAWLINS RACING ASSOCIATION

Art Canaday, representing Rawlins Racing Association, requested Carbon County's assistance with dirt moving on newly acquired land south of Rawlins, the future site of their raceway. The request was taken under advisement.

UPPER PLATTE RIVER SOLID WASTE DISPOSAL DISTRICT

A motion was made by Fleming, seconded by Graalman, and unanimously carried to appoint Alice White to the Upper Platte River Solid Waste Disposal District Board effective October 1996.

RED CROSS

Don Brinkman, Chief Executive Officer of the local Red Cross chapter, gave a brief outline of local Red Cross emergency responsibilities and funding. Following the presentation, Brinkman requested \$10,000 from the County's 1997-98 budget to pay a portion of the new Red Cross manager's salary and equip three Rawlins emergency shelters.

PLANNING

Carbon County planning consultant, Jim Pedersen, and Carbon County Planning Commission member, Henry Hewitt updated the Commissioners on various planning and zoning activities, including Sea West's wind turbine project.

SEARCH AND RESCUE

President of Carbon County Search and Rescue, Margaret Logan presented honorary membership certificates and window stickers to the three Commissioners in recognition of their past support of Search and Rescue.

CARBON COUNTY COALITION

Representatives of the Carbon County Coalition in conjunction with the Carbon County Commissioners scheduled a brown bag luncheon on June 3rd in the Commissioner's meeting room of the courthouse from noon to 1:30 p.m. Professor Hayward, from the University of Wyoming, will give a technical lecture on old growth forest management.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into executive session for the purpose of discussing personnel (3:00 p.m.).

A motion was made by Fleming, seconded by Graalman, and unanimously carried to come out of executive session (3:25 p.m.).

FIRE DEPARTMENT

County Fire Warden, Dwight France reported on the Ryan Park and Elk Mountain fire trucks currently being readied in the Rawlins shop and due to be delivered within the next two weeks. France also reported his intention to advertise for bids on a new suburban to be used as a fire personnel transport vehicle. France requested \$2,500 from the strike team fund to establish a reimbursable account to pay strike team expenses.

The Commissioners signed an amended annual operating plan between the Bureau of Land Management, the State Forestry Division, the National Forest Service, and Carbon County Government for cooperative fire suppression in Carbon County.

CARBON BUILDING

Carbon Building Maintenance Supervisor, Patty Schuler reported on a bid request from the State of Wyoming Department of Corrections for office space to be used by Probation and Parole in the Carbon Building.

Schuler also presented a \$2,680 bid from L.M. Olson to repair mortar on the west end of the Carbon Building. The Commissioners approved the repair.

Schuler discussed the perpetual roof leaks at the Carbon Building and asked the Board for direction in finally repairing the ongoing problem the original contractor is unable to correct. The Commissioners authorized Schuler to take whatever avenue necessary to solve the problem and Schuler was also directed to contact Wade Waldrip, the county's civil attorney, for recourse on the warranty from the original contractor.

A presentation was made by Schuler and Road & Bridge supervisor, Bill Nation on A.D.A. approved door latch and lock systems. Schuler requested approval to install the lock systems on the third floor of the Carbon Building and has requested funding in the 1997-98 budget to complete lock installations on the remaining two floors. The Commissioners approved the lock replacements on the third floor of the Carbon Building.

SENIOR CENTER

The Commissioners signed an agreement with Montgomery KONE to perform the annual pressure relief test on the Rawlins Senior Center elevator.

ROAD & BRIDGE

Bill Nation, County Road & Bridge Supervisor, presented his administrative report for the period of April 16th through May 6th.


ADJOURNMENT
