## 1% CAPITAL FACILITIES SALES AND USE TAX

A motion was made by Linda Fleming, seconded by Gary Graalman and carried to approve and adopt the following resolution:

R E S O L U T I O N 1997 - 5

A RESOLUTION APPROVING THE PROPOSITION FOR IMPOSITION OF A 1% CAPITAL FACILITIES SALES AND USE TAX IN CARBON COUNTY, WYOMING, FOR THE EXCLUSIVE PURPOSE OF FUNDING SPECIFIC PURPOSES IN SPECIFIC AMOUNTS, SAID PROPOSITION TO BE PLACED ON THE BALLOT AT A SPECIAL ELECTION TO BE HELD IN CARBON COUNTY ON TUESDAY, NOVEMBER 4, 1997.

WHEREAS, pursuant to W.S. 39-6-412(k) and 39-6-518(e), counties may impose an excise tax not to exceed one percent (1%) upon retail sales of tangible personal property, admissions and services made, and upon storage, use and consumption of tangible personal property, within the county, for specific purposes and in specific amounts as authorized by the qualified electors of the county (hereinafter the "Tax"); and

WHEREAS, the Board of County Commissioners (the "Commissioners") of Carbon County, Wyoming (the "County" or "Carbon County"), in response to the needs of the County and requests received from the governing bodies of the Towns of Baggs, Wyoming ("Baggs"), Dixon, Wyoming ("Dixon"), Elk Mountain, Wyoming ("Elk Mountain"), Encampment, Wyoming ("Encampment"), Hanna, Wyoming ("Hanna"), Medicine Bow, Wyoming ("Medicine Bow"), Riverside, Wyoming ("Riverside"), Saratoga, Wyoming ("Saratoga"), Sinclair, Wyoming ("Sinclair") and the City of Rawlins, Wyoming ("Rawlins") (hereinafter the County, Baggs, Dixon, Elk Mountain, Encampment, Hanna, Medicine Bow, Riverside, Saratoga, Sinclair and Rawlins being sometimes individually referred to as "Sponsoring Entity" and collectively referred to as "Sponsoring Entities"), has determined to make such source of funding available in the following specific amounts for the following specific purposes (the "Projects"):

1. \$1,500,000 to the County for the payment of debt service on outstanding revenue obligations for Carbon County Memorial Hospital (\$1,000,000), for roof, gutter and downspout repairs at the Wyoming Frontier Prison (Old Pen) (\$300,000) and for the purchase of ambulances (\$200,000);

2. \$250,000 to Baggs for the construction of water system improvements (\$200,000) and sewer system improvements (\$50,000);
3. \$150,000 to Dixon for the payment of debt service on outstanding water debt;
4. \$200,000 to Elk Mountain for the payment of debt service on outstanding water debt;
5. \$687,500 to Encampment for the construction of water system improvements;
6. \$852,500 to Hanna for the purchase of a fire truck (\$187,500), for the construction of water system improvements (\$646,250) and for sewer system improvements (\$18,750);
7. \$735,000 to Medicine Bow for the construction of sewer system improvements (\$675,000) and for the payment debt service on outstanding water debt (\$60,000);
8. \$209,000 to Riverside for the payment of debt service on outstanding water and sewer debt;
9. \$761,583 to Saratoga for the construction of water system improvements (\$126,930) and street improvements (\$634,653);
10. \$400,000 to Sinclair for the construction of water system improvements; and
11. \$4,375,000 to Rawlins for the construction of a water supply, treatment and transmission system; and

WHEREAS, pursuant to the provisions of W.S. 39-6-412(k)(iii), before any proposition to impose the Tax shall be placed before the electors of the County, the Commissioners and the governing bodies of at least two-thirds (2/3) of the incorporated municipalities within the County shall adopt a resolution approving the proposition, setting forth a procedure for qualification of a ballot question for placement on the ballot and specifying how excess funds shall be expended; and

WHEREAS, the Commissioners have determined that it is necessary to submit to the qualified registered electors of the County the proposition for imposition of the Tax;

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS OF CARBON COUNTY, WYOMING, THAT:

Section 1. At a specified election to be held in Carbon County, Wyoming, on Tuesday, November 4, 1997, between the hours of 7:00 A.M. and 7:00 P.M., there will be submitted to the qualified registered electors of the County the proposition of imposing a 1% capital facilities sales and use tax for the exclusive purpose of funding specific projects, as more particularly set forth in the Proclamation and Notice of Election.

Section 2. The election on the proposition shall be held at the Election Districts, Precincts and Polling Places as more particularly set forth in the Proclamation and Notice of Election.

Section 3. Any qualified registered elector in the County shall be entitled to vote on the proposition in person or by absentee ballot, in the precinct in which he or she is registered. A qualified registered elector includes every citizen of the United States who is a bona fide resident of Wyoming and Carbon County, has registered to vote not less than 30 days before the election and who will be at least eighteen (18) years of age on the day of the election.

Absentee voting on the proposition is permitted as hereinafter provided in the Proclamation and Notice of Election.

Section 4. The votes for and against the proposition, including absentee votes, shall be registered on electronic ballot punch cards. The ballot cards shall set forth the following proposition:

"Shall Carbon County, Wyoming, be authorized to adopt and cause to be imposed a one-percent (1%) capital facilities sales and use tax and collect a total of \$10,120,583, the proceeds from which and the interest earned thereon to be used and applied in the manner determined by the Sponsoring Entities for funding the planning, engineering, improving, upgrading, construction or reconstruction, equipment and repairs and, to the extent necessary and allowed by law, the pledge to or payment of debt service and/or lease payments thereon, in the specified principal amounts and for the specified purposes provided below:

\$1,500,000 to Carbon County for the payment of debt service on outstanding revenue obligations for Carbon County Memorial Hospital (\$1,000,000), for roof, gutter and downspout repairs at the Wyoming Frontier Prison (Old Pen) (\$300,000) and for the purchase of ambulances (\$200,000);

\$250,000 to the Town of Baggs for the construction of water system improvements (\$200,000) and sewer system improvements (\$50,000);

\$150,000 to the Town of Dixon for the payment of debt service on outstanding water debt;

\$200,000 to the Town of Elk Mountain for the payment of debt services on outstanding water debt;

\$687,500 to the Town of Encampment for the construction of water system improvements;

\$852,500 to the Town of Hanna for the purchase of a fire truck (\$187,500), for the construction of water system improvements (\$646,250) and for sewer system improvements (\$18,750);

\$735,000 to the Town of Medicine Bow for the construction of sewer system improvements (\$675,000) and for the payment of debt service on outstanding

water debt (\$60,000);

\$209,000 to the Town of Riverside for the payment of debt service on outstanding water and sewer debt;

\$761,583 to the Town of Saratoga for the construction of water improvements (\$126,930) and street improvements (\$634,653);

\$400,000 to the Town of Sinclair for the construction of water system improvements; and

\$4,375,000 to the City of Rawlins for the construction of a water supply, treatment and transmission system."

The ballot cards shall be inserted into the voting device. The elector indicates his or her vote on the proposition on the punch card by piercing the card with a punch device to punch a hole opposite the words "FOR THE COUNTY CAPITAL FACILITIES TAX" or "AGAINST THE COUNTY CAPITAL FACILITIES TAX" expressing his or her choice.

Section 5. The County Clerk shall cause the Proclamation and Notice of Election to be published at least once in the Rawlins Daily Times, in Rawlins, Wyoming, and the Saratoga Sun, in Saratoga, Wyoming, newspapers of general circulation in the County, not less than thirty (30) days nor more than forty (40) days before the date of election. The Proclamation and Notice of Election shall specify the name of the County, the date, time and place of election, the proposition to be submitted and the fact that only qualified registered electors of the County will be permitted to vote thereon. In addition, there shall be published a Notice of Registration, which shall set forth the last day for registration in the event that a qualified elector is not presently registered. The Notices shall be in substantially the following form:

The polls will open at 7:00 A.M. and will close at 7:00 P.M. on the day of the election. Any registered elector of the County shall be entitled to vote on the proposition in person or by absentee ballot in the precinct in which he or she is registered. A qualified registered elector includes every citizen of the United States who is a bona fide resident of Wyoming and Carbon County, has registered to vote not less than 30 days before the election and who will be at least eighteen (18) years of age the day of the election.

The votes cast, including absentee votes, shall be by electronic voting systems at least one of which shall be at each polling place. The electronic ballot cards shall contain the same proposition as stated above and a voting device will be provided to permit the elector to indicate his or her vote "FOR THE COUNTY CAPITAL FACILITIES TAX" or "AGAINST THE COUNTY CAPITAL FACILITIES TAX" expressing his or her choice. Instructions to the elector will be provided to assist the elector in casting his or her vote.

If at such election it shall appear that a majority of the qualified registered electors voting on the proposition are in favor of adopting the 1% capital facilities sales and use tax, the tax shall become effective commencing January 1, 1998.

Any qualified registered elector may vote by absentee ballot. A qualified registered elector may apply for an absentee ballot either in person, in writing, or by telephone (307) 328-2668, by furnishing the information required by law; applications should be made to W.E. Harshman, Carbon County Clerk, Carbon County Courthouse, 4th and Pine Street, Rawlins, Wyoming 82301. Such application should be made not later than the close of business on the last business day prior to the election.

NOTICE OF REGISTRATION

NOTICE IS HEREBY GIVEN that the proposition of imposing a 1% capital facilities sales and use tax in Carbon County, Wyoming, will be submitted at a special election to be held on Tuesday, November 4, 1997.

In order to vote at this election, an elector must be a qualified elector who has registered to vote not less than 30 days before the date of the election. Persons who are otherwise qualified to vote, but who are not presently registered, may register at the Office of the Carbon County Clerk, W.E. Harshman, Carbon County Courthouse, in Rawlins, Wyoming or at the offices of the Town Clerks or Town Clerk-Treasurers, during their regular business hours, in Baggs, Dixon, Elk Mountain, Encampment, Hanna, Medicine Bow, Riverside, Saratoga, and Sinclair, not later than the close of business on Monday, October 6, 1997.

A Proclamation and Notice of Election giving more detailed information concerning the election, will be published as required by law on October 1, 1997.

Section 6. The results disclosed by the canvass of votes shall be certified by the election officials to the County Clerk of Carbon County, Wyoming. If the majority of votes cast on the proposition at the election is in favor of the imposition of the Tax, such proposition shall be approved and the Board of County Commissioners, in the manner provided by law, shall then proceed to declare the results of the election, and complete all steps necessary for the imposition of the Tax.

Section 7. The Election of the proposition shall be held, conducted and the results canvassed as provided by the Wyoming Election Code of 1973, as amended, more particularly the Political Sub-division Bond Election Law (W.S. 22-21-101 to 22-21-111, inclusive).

Section 8. In the event the proposition shall be approved by the qualified registered electors of Carbon County, the Tax shall commence on January 1, 1998. Upon distribution of the Tax funds to the Sponsoring Entities (or such lesser amount if the Sponsoring Entities have agreed to terminate the Tax pursuant to the provisions of W.S. 39-6-412 (k)(xi), excess Tax funds shall be retained by the Carbon County Treasurer for one (1) year for refund of overpayments. After one (1) year, the excess Tax funds (less any refunds), plus any interest earned thereon, shall be distributed to each Sponsoring Entity based upon the respective ration which the principal amount of each Project approved bears to the total principal amount of all Projects approved. The excess Tax funds, and interest thereon, shall be used for additional construction, operation, equipment and maintenance of the specified Projects.

Section 9. Before the proposition may be placed before the qualified registered electors of Carbon County, the Commissioners and the governing bodies of at least two-thirds (2/3) of the incorporated municipalities within the County must adopt resolutions as required by W.S. 39-6-412 (k)(iii).

Section 10. The passage of this resolution shall constitute written notification to the County Clerk, specifying the date of the election and the proposition, not later than August 26, 1997, pursuant to the provisions of W.S. 22-21-103, and shall further constitute approval as required by W.S. 39-6-412 (k)(iii).

Section 11. Should any part or provision of this resolution ever be judicially determined to be invalid or unenforceable, such determination shall not affect the remaining parts and provisions hereof, the intention being that each part or provision of this resolution is severable.


