CARBON BUILDING

Tom Peak, Johnson Controls representative reported on the lighting efficiency improvement project completion. Peak also gave a progress report on the retro-fitting of the furnace system.

Patricia Schuler, Carbon Building Manager reported on operations at the Carbon Building.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Graalman and carried to enter into executive session to discuss personnel and pending litigation. (10:58 a.m.)

A motion was made by Graalman, seconded by Fleming and carried to come out of executive session. (11:35 a.m.)

TREASURER

County Treasurer, Cindy Baldwin gave her administrative report.

PLANNING

A public hearing was held at 2:00 p.m. to consider planning zone changes.

A motion was made by Fleming, seconded by Graalman, and unanimously carried to support the Planning Commission recommendation to deny Case File 97-09, James and Sandra Pedersen. Rezone from RAM (Ranch-Agriculture-Mining) to RD (Residential), with consent from applicants.

A motion was made by Graalman, seconded by Fleming, and carried to approve Case File 97-10, Robert Weber. Rezone from RAM to RD - 2.5 (one dwelling allowed per 2.5 acres).

November 4, 1997

Henry Hewitt presented the Planning Commission report.

CONTRACT COMPUTER SERVICE

Kermit Tipton, computer consultant requested renewal of his contract. A motion was made by Fleming, seconded by Graalman, and carried to renew the contract for an additional year.

COMMUNITY SERVICE BLOCK GRANT

A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into a contract with the State of Wyoming Department of Health and Social Services. A copy of the agreement is on file in the County Clerk's office.

NORTHWEST RYAN PARK WATER & SEWER DISTRICT

A motion was made by Fleming, seconded by Graalman, and unanimously carried to support the Northwest Ryan Park Water & Sewer District grant application in the amount of \$480,821 from the State Board of Lands and Investments for the design and construction of the water system at Ryan Park.

PRENATAL INSTRUCTOR SERVICES AGREEMENTS

A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into agreements with Joyce Graham LPN and Tamara Lundberg MSN, FPN. Graham and Lundberg will provide prenatal instruction to Carbon County Public Health Nursing Service clients.

SYMPHONY HEALTH SERVICES

A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into an agreement with Symphony Rehabilitation to supply temporary or long term therapist needs to Carbon County Public Health Nursing Service clients.

LONG TERM HEALTH CARE

A motion was made by Graalman, seconded by Fleming, and unanimously carried to enter into an agreement with Marci Newell to provide long term health care to Carbon County Public Health Nursing Service clients.

CARBON COUNTY SENIOR CENTERS

A motion was made by Graalman, seconded by Fleming and unanimously carried to terminate the Rawlins Senior Center lease with Carbon County Senior Services, Inc.


ROAD & BRIDGE
