PUBLIC HEALTH NURSING - Jenny Lueallen

Jenny Lueallen wants to enter into an agreement between Lutheran Hospitals and Homes Society of America DBA LHS Home & Community Care and Carbon County Public Health Nursing Services. No action taken at this time.

SENIOR SERVICES

Paul Scott updated the Commissioners on the activities of the Senior Center.

HOUSE BILL #83

Sinclair Councilman, George McCann, would like the Commissioners to back House Bill #83 that would allow Municipal Governments to deposit monies into Credit Unions. No action taken at this time.

PLANNING - Jim Pedersen

Concerning Case File #96-17, a motion was made by Linda Fleming, seconded by Gary Graalman, and unanimously carried to approve zone change from RAM to RD, Lot 18, 2,263 acres, Sierra Madre Subdivision.

A motion was made by Linda Fleming, seconded by Gary Graalman and unanimously approved the planning memorandum dated January 7, 1997 which confirms the following information:

1. Cow Creek Station Subdivision represents a planned unit development that was approved by the Carbon County Planning Commission and the Board of County Commissioners on October 8, 1980;
2. The size of the 49 lots in this subdivision varies between 3.89 and 6.67 acres.
3. Only one dwelling unit is permitted for each of the 49 lots that are contained in the subdivision.

JOHNSON CONTROLS

A proposal was given by Johnson Controls for the upgrade of heating and air-conditioning for the Carbon Building.

FIRE DEPARTMENT

Dwight France informed the Commissioners that his budget is running low. He is requesting \$6,000.00.

A motion was made by Linda Fleming, seconded by Gary Graalman and unanimously carried to re-appoint Jerry Kraft as Director in Area IV, Leo Chapman as Director in Area I, and Pres Williams as Director in Area III on the Weed and Pest Control Board. All three terms expire on January 3, 2001.


ROAD & BRIDGE


