## PROCLAMATION

A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously carried to sign the following proclamation:

## PROCLAMATION

WHEREAS, every man, woman and child who is victimized by crime in America deserves to be treated with dignity and compassion, and deserves services and support to help them in the aftermath of crime; and

WHEREAS, annually, there are over 39 million people in the United States who are victimized by crime, 10 million of whom are victims of violent crime; and

WHEREAS, the physical, financial and psychological effects of crime have a devastating impact upon victims and the fabric of our great nation; and

WHEREAS, there are over 10,000 professional and volunteer agencies in the United States, including two (2) in Carbon County, Wyoming, that are committed to helping victims of crime and promoting safety and security for us all; and

WHEREAS, the citizens of Carbon County, Wyoming and their elected representatives believe that victims should have the right to participate in justice processes and be provided with information about their cases, and that offenders should be held fully accountable for their criminal actions; and

WHEREAS, April 13 to 19, 1997 is "National Crime Victims' Rights Week," a special commemoration when we join together to "let victims' rights ring across America," THEREFORE, BE IT

RESOLVED, that the Carbon County Commissioners proclaim the week of April 13 to April 19, 1997 to be Carbon County, Wyoming Crime Victims' Rights Week, AND BE IT FURTHER

RESOLVED, that the citizens of Carbon County, Wyoming commit our individual and collective resources in a chorus that lets victims' rights ring across our community and nation; AND BE IT FURTHER

RESOLVED, that a suitable prepared copy of this proclamation be presented to Carbon County Victims' Advocate and Carbon County C.O.V.E. and Carbon County Commissioners.

## ACCESS ROAD HEARING - NORTH HANNA

The Commissioners held a public hearing to hear any public protest and/or comments regarding the authorization to submit a grant application to the Abandoned Mine Land Program for funding for the North Hanna Access Road Project.

The Commissioners voted unanimously on a motion made by Gary Graalman, seconded by Linda Fleming to submit a grant application to the Abandoned Mine Land Program for the Design and Construction of the North Hanna Access Road Project in Hanna, Wyoming.

## RESOLUTION

A motion was made by Gary Graalman, seconded by Linda Fleming and unanimously carried to adopt the following:

R E S O L U T I O N 1 9 9 7 - 3

A RESOLUTION AUTHORIZING SUBMISSION OF A GRANT APPLICATION TO THE ABANDONED MINE LAND PROGRAM ON BEHALF OF THE GOVERNING BODY FOR THE CARBON COUNTY BOARD OF COMMISSIONERS FOR THE PURPOSE OF DESIGN AND CONSTRUCTION OF THE NORTH HANNA ACCESS ROAD PROJECT.

WITNESSETH

WHEREAS, the Governing Body for the Carbon County Board of Commissioners desires to participate in the ABANDONED MINE LAND GRANT program to assist in financing this project; and

WHEREAS, the Governing Body of the Carbon County Board of Commissioners recognizes the need for the project; and

WHEREAS, the Abandoned Mine Land Grant program requires that certain criteria be met, as described in the Abandoned Mine Land Program's Rules and Regulations governing the program, and to the best of our knowledge this application meets those criteria; and

WHEREAS, the Governing Body of the Carbon County Board of Commissioners plans to match the requested 64% Abandoned Mine Land Program Grant with 36% matching funds from the following sources:

19% - State - County (SC) Road Program, Not to Exceed \$360,000.00  
 17% - Arch of Wyoming Contribution, Not to Exceed \$340,000.00

NOW, THEREFORE, BE IT RESOLVED BY THE GOVERNING BODY OF THE Carbon County Board of Commissioners, that a grant application in the amount of \$1,234,000.00 be submitted to the Abandoned Mine Land Program to assist in funding the DESIGN AND CONSTRUCTION OF THE NORTH HANNA ACCESS ROAD PROJECT.

BE IT FURTHER RESOLVED, that Artlin Zeiger, Chairman is hereby designated as the authorized representative of the Carbon County Board of Commissioners to act on behalf of the Governing Body on all matters relating to this grant application.


