Scott Thomas, representing the City of Rawlins, presented a proposal for a Hadsell Road overlook interpretive area located off Interstate 80. Thomas asked the County for a contribution of two (2) cattleguards to be installed this fall. The BLM will provide interpretive signs and there will be no fee for the development. The City of Rawlins will take care of the trash and toilets.

Bill Nation, County Road & Bridge supervisor presented cattleguard production costs and reported that the road would need improvement. Nation will do an on-site inspection with Scott Thomas.

The Commissioners agreed to support the Hadsell Road project.




