

**COMMISSIONER PROCEEDINGS
REGULAR MEETING
September 15, 1998**

The Carbon County Board of Commissioners met at 7:00 p.m. in the Encampment Senior Center, Encampment, Wyoming. Present were commissioners Linda Fleming, Gary Graalman, and Artlin Zeiger, Chairman.

K.I.D.S., INC.

Greta Lucero, director of K.I.D.S., Inc. requested their employees be included on the self-funded health insurance plan sponsored by Carbon County Government. The request was taken under advisement.

ROAD & BRIDGE

Carbon County Road & Bridge department supervisor, Bill Nation presented an administrative report covering the following projects:

Crews have been completing summer projects while maintaining and improving school bus routes in all areas of the county.

Soil stabilizer/dust suppressant will be applied next week in the Saratoga, Baggs, and Savery areas.

Legal work for the slide area road change on C.C. R. #101, south of Elk Mountain is being sent out for landowner signatures. County Civil Attorney, Wade Waldrip will at a future commissioner meeting, presents for formal resolution the required paperwork.

The State/County (SC) \$50,000.00 annual funding allocation has been received in the County Clerk's office. An expenditure account has been established in the Grant & Reimbursement category.

C.C.R. #385 – North Spring Creek Spur (Transfer Road)
Nation met with the three landowners along this road. The landowners want "Private Land Stay On Road" signs up on both ends of the road. Six to seven culverts, gravel, two new cattleguards and the resetting of two existing cattleguards are needed to get the road up to good shape status.

Nation presented for consideration an agreement providing reimbursement to the County for labor and material costs incurred posting new advance railroad warning signs along roads maintained by Carbon County. A motion was made by Fleming, seconded by Graalman, and unanimously carried to enter into the agreement with the Transportation Commission of Wyoming. The document was signed by Commission Chairman Artlin Zeiger, attested by County Clerk Teddy Yockey, and given to Nation for submission to the State of Wyoming.

County Clerk Teddy Yockey presented, for County Treasurer Cindy Baldwin, a bid submitted by Roland E. Kahler for the purchase of property owned by Carbon County described as follows:


