WHEREAS, the Carbon County Planning Commission has undergone the task of drafting a land use plan, held public hearing, taken public comments, incorporated those comments into the draft plan, and reviewed for legitimacy, has produced a Final Draft Land Use Plan.

WHEREAS, the Carbon County Planning Commission, at a regularly scheduled public meeting, recommended for approval that Final Draft Land Use Plan on April 7, 1998.

WHEREAS, the Carbon County Planning Commission submitted the Final Draft Land Use Plan to the Carbon County Board of Commissioners for review and adoption.

WHEREAS, on June 2, 1998 the Carbon County Board of Commissioners held a publicly noticed open hearing to accept comments from the public on the recommended Final Draft Land Use Plan.

WHEREAS, the Board of Carbon County Commissioners, at their regular meeting on June 16, 1998, after consideration of all comments received through the Land Use Plan Development process, at public hearings, and through written submittals from both the public and governmental agencies, deems the Final Draft Land Use Plan, as submitted by the Planning Commission, to meet legal sufficiency, to address the concerns of the residents of Carbon County, and represents appropriate planning practices.

NOW, THEREFORE, IT IS HEREBY RESOLVED, that the Carbon County Board of Commissioners hereby approves and adopts the Carbon County Land Use Plan.
