CHAIRMAN

A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to reappoint Artlin Zeiger as chairman of the Board of Commissioners. Artlin Zeiger and Linda Fleming welcomed new Commissioner Lee Meacham.

HEALTH INSURANCE

Brent Hillier is scheduled to be here for the 1st meeting in February to discuss the county insurance.

STATE BOARD OF DIRECTORS

Artlin Zeiger volunteered to represent the Commissioners from Carbon County on the Commissioners Board of Directors for the State of Wyoming.

SENIOR SERVICES

Discussion was held on roof repair for the Senior Services building in Baggs. John Peery is to be contacted to get bids and submit them to the Commissioners. Linda Fleming will also have a contractor in Baggs evaluate whether a new roof is needed or if the existing roof can be repaired.

WEED AND PEST

Larry Justesen was in attendance to check on reappointments for the Carbon County Weed & Pest Control Board.

A motion was made by Fleming, seconded by Meacham and unanimously carried to reappoint Steve Adams and Gary Vivion to a four (4) year term from January 3, 1999 to January 3, 2003.

TREASURER

Disclosures were received from Cindy Baldwin, Carbon County Treasurer and Joy Hannum, Deputy Carbon County Treasurer. Per Statutory requirements, the Carbon County Commissioners, the County Clerk, the Carbon County Treasurer and Deputy County Treasurer are required to disclose all interests in any banking institutions in which Carbon County has money invested.

A motion was made by Fleming, seconded by Meacham and unanimously carried to name the Bank of Commerce, Community First National and the Rawlins National Bank as the official depositories for Carbon County Government.

FIRE DEPARTMENT

Dwight France was in attendance to update the Commissioners on projects in his department.

A letter was received by Olin Sims, Fire Chief in McFadden that the building that houses the fire equipment in McFadden had to be vacated by the 1st of December 1998. The building is not owned by the County but by an oil company that has allowed the County to use the building.

Olin Sims has some property that he would be willing to donate to the County with certain conditions. France recommended constructing a three (3) bay steel insulated building which could also be used as a community meeting center. The Commissioners instructed France to get building costs, no bids just proposals.

Two (2) diesel 6x6's were purchased from Wyoming Surplus for Ryan Park and Medicine Bow. Their old trucks will be sent back to Wyoming State Forestry. France would like to purchase two (2) more Chassis. Fleming suggested to France that if they can work out of their own budget, the Commissioners would approve the purchase. Zeiger told France to go ahead and commit. France said they would be swapping out a 6x6 in Medicine Bow to sell so those proceeds could be used toward the Chassis purchase.

France informed the Commissioners of the problems with fire fighters being paged out in the Rock River, Arlington and McFadden areas.

CONCERNED CITIZEN

Scott Kerbs dropped by as a concerned citizen to express his concern on subdivisions. He had attended the meeting of the Planning & Development earlier that morning.

ADJOURNMENT

The Carbon County Board of County Commissioners adjourned for lunch at 12:00 p.m. (Noon)

READJOURNMENT

The Board of County Commissioners reconvened following a break for lunch at 2:00 p.m.

PLANNING & DEVELOPMENT

Henry Hewitt and Jonathan Schnal were both in attendance to update the Commissioners on their department. They informed the Commissioners that there were no action items that needed to be discussed.

In regards to Case File 98-16, Ralph & Pat Zordel & Larry Barraillers request to rezone from Ranch-Agriculture-Mining (RAM) to Residential Development (RD), the hearing was tabled by the Planning Commission because they felt they needed more information before making a decision.

Artlin Zeiger declared the hearing open on the zoning request. The recommendation was that the Planning Department prepare a secondary packet which would answer certain questions regarding access, title, history of subdivision, ownership etc.

A motion was made by Fleming, seconded by Meacham and unanimously carried to table this zone request until more information is provided.

Case File 98-13, 98-14, and 98-15 involved requests for Special Use Permits to allow construction of fiber-optic regenerator buildings in a RAM district. The Planning Commission approved these three (3) Special Use Permits. Discussion followed whether others can link into this fiber-optic line. Henry Hewitt feels the Economic Development Department needs to look into this further.

Three (3) active violations were also discussed. A decision was made to go into Executive Session with Tom Campbell, Carbon County Attorney to further discuss these violations.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Meacham and unanimously carried to enter into Executive Session with Henry Hewitt, Jonathan Schnal and Tom Campbell at 2:40 p.m.

A motion was made by Fleming, seconded by Meacham and unanimously carried to come out of Executive Session at 3:12 p.m.

OTIS ELEVATOR COMPANY

Representatives from Otis Elevator discussed the problems they encountered with the courthouse elevator. They felt if the elevator is properly maintained it should last a long time.

Fleming discussed the need for hand rails that John Peery needed in the Senior Services elevator.

FAIRBOARD

Cris Waldrip introduced Randy Shellito who is the new caretaker for the fairgrounds. He was welcomed by all of the Commissioners.

ROAD & BRIDGE

Bill Nation, Carbon County Road & Bridge Supervisor and Wade Waldrip, County Civil attorney were in attendance to discuss pending litigation.

EXECUTIVE SESSION

A motion was made by Fleming, seconded by Meacham and unanimously carried to enter into Executive Session with Bill Nation and Wade Waldrip to discuss pending litigation at 3:35 p.m.

A motion was made by Fleming, seconded by Meacham and unanimously carried to come out of Executive Session at 4:35 p.m.

ROAD & BRIDGE

Bill Nation gave his administrative report.

Nation reported on the following projects:

Throughout the County, continuing to maintain and monitor all school bus routes.

Hauled load of coal to Muddy Gap for Carbon County Fire Department.

Last November/December, hauled and spread 2000 yards to both County Road #500 - Jack Creek Road and County Road #291 - North Hanna Road

Will continue hauling of cold mill mix from the Walcott Pit as work scheduling and weather permits. Have requested an additional 2,200 cubic yards from WY DOT for use on county roads and projects in 1999.

Have completed 1000 hours, oil and maintenance on Elk Mountain blade. Started back on re-build kit on Western Star truck. Changed out re-built snow wing on Rawlins area blade and continue to pour cattle guard blocks.

Reviewed a Memorandum of Understanding (M.O.U.) between Sweetwater County and the Bureau of Land Management (BLM) in regards to the Continental Divide/Wamsutter II Transportation Project.

A motion was made by Lee Meacham, seconded by Linda Fleming and unanimously carried to sign the M.O.U. between Sweetwater County and the BLM.

SEMINOE ROAD

Andy Long of the Wyoming Department of Transportation (WDOT) discussed Part B of Phase II of the Seminoe Dam Road. Long estimated that the total cost of the Seminoe road project would be 5.925 million. A motion was made by Linda Fleming, seconded by Lee Meacham and unanimously carried to enter into an agreement with the Wyoming Department of Transportation (WDOT) to use funds in regards to Seminoe Dam Road - Phase, Federal Project #FLH 6-54, State Project #SC-CFM 6-54.

ROAD & BRIDGE

The Commissioners also signed an agreement giving Bill Nation authority to sign for them in matters that need immediate attention with the Wyoming Department of Transportation as long as he keeps the Commissioners informed.

NORTH HANNA ACCESS ROAD PROJECT

Paul McCarthy of PMPC Engineering Consultants updated the Commissioners on the North Hanna Road Project. He reported that the reconnaissance program is completed. Mr. McCarthy plans to come and update the Commissioners on this project on a monthly basis.

MUSEUM BOARD

A letter of resignation was received from Dorothy Wolfard effective January 1, 1999. The term runs until July 1, 2000.

OFFICIAL PUBLICATIONS




MEETING DATES
