CLERK

County Clerk Linda Ann Smith presented Grant Draft Request No. 3 for the McFadden Fire Hall, bonds, and the Clerk's monthly statement for approval and signatures.

A motion was made by Lee Meacham and seconded by Linda Fleming to approve and sign for publication, the gross salary roster for full-time Carbon County employees. The motion carried unanimously.

In a recent City fire inspection, it was determined that extension cords being used throughout the Courthouse building are a fire hazard. By order of the Commissioners, all light extension cords are to be eliminated from use in the building, and replaced with acceptable heavy duty cords.

SHERIFF'S DEPARTMENT

Sheriff Colson informed the Commissioners that a grant for Victim's Advocates Program is soon to end. He stated that he believes the City of Rawlins is proposing to drop the grant and make the Advocate a regular full-time City employee. The Commissioners instructed Sheriff Colson to apply for the grant as usual, and if the grant is not received, the position will be discussed for the next fiscal year during preparation of the budget.

Linda Smith was instructed to draft a letter of support for the grant on behalf of the Commissioners.

NATIONAL GUARD ARMORY.

Commissioner Meacham reported that he has been in contact with the Adjutant General's office in Cheyenne concerning the new developments in the National Guard Armory in Rawlins. He stated that it has been determined that the State cannot give away the armories unless they are to another state agency. However, they are willing to sign a 5-year lease with the County, act as landlords for the building and land, thus eliminating the expense of maintenance for the building and custodial costs to the County. Commissioner Meacham was instructed to keep the Board apprised of the situation.

ROAD & BRIDGE

Gary Steele of PMPC updated the Commissioners on the Seminole Dam Road projects.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve Grant Request #5 (MRG-1689) to the State Land and Investment Board for the Hanna Access Road in the amount of \$188.07. The motion carried unanimously.


A motion was made by Linda Fleming and seconded by Lee Meacham to approve the invoice for PMPC for Seminole Dam Road Phase 3 in the amount of \$28,838.52. The motion carried unanimously.

Bill Nation presented his bi-monthly report to the Commissioners.

ADJOURNMENT

There being no further business, the meeting was adjourned at 8:45 p.m.
