REGULAR MEETING
TUESDAY, FEBRUARY 1, 2000

MINUTES

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the minutes of the January 18, 2000. The motion carried unanimously.

CLERK

A motion was made by Linda Fleming and seconded by Lee Meacham to appoint John Cowdin to the Fair Board. The motion carried unanimously.

The resignation of Zoda Furguson from the Library Board was accepted with regret.

The Commissioners invited personnel from Techniscan to address the roof project at the next regular meeting.

ELECTIONS

Kathy Makinen, Elections Clerk, reported that there are only 6 registered voters in Seminoe Dam Precinct 5-1, and recommended that 5-1 be combined with Sinclair Precinct 16-1 to facilitate compliance with state election codes regarding election judges.

A motion was made by Linda Fleming and Seconded by Lee Meacham to combine Seminoe Dam District 5, Precinct 1 with Sinclair District 16, Precinct 1. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to increase the daily meal allowance for election judges from \$11.00 per day to \$13.00 per day. The motion carried unanimously.

Because the mileage was increased for county employees at an earlier Commissioners meeting, mileage for election personnel will also be paid at \$.28 per mile, if election personnel travel over six miles.

A motion was made by Lee Meacham and seconded by Linda Fleming to increase the wage of election judges to \$6.00 per hour. The motion carried unanimously.

SENIOR CENTERS

Bill Michie, Director, gave his monthly report, and introduced Jesse Salinas as the new site manager.

CARBON COUNTY FAIR BOARD

A motion was made by Linda Fleming and seconded by Lee Meacham to sponsor the trophies for the Grand Champion winners at the 2000 County Fair in the amount of \$45.00. The motion carried unanimously.

MCFADDEN FIRE STATION

Dwight France reported on the progress of the McFadden Fire Station.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept Change Order #2 for the relocation of light switches at the McFadden Fire Station in the amount of \$541.10. The motion carried unanimously.

EXECUTIVE SESSION

A motion was made by Lee Meacham and seconded by Linda Fleming to move into Executive Session at 11:21 a.m. to discuss pending litigation. The motion carried unanimously. A motion was made by Linda Fleming and seconded by Lee Meacham to come out of Executive Session at 12:03 p.m. The motion carried unanimously.

SHERIFF

Sheriff Jerry Colson updated the Commissioners on his discussions with National Institute of Corrections. Lee Meacham will represent the Commissioners on the board being established to make recommendations on the new jail proposal.

Sheriff Colson reported that two bids were received for the radio console. Those bids were:

Communications Source of Cheyenne -	\$43,970 (Motorola)
Ryan Electronics – Saratoga	\$23,999.01 (Motorola)

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the bid of \$23,999.01 for the radio console for the Sheriff's Department as submitted by Ryan Electronics in Saratoga. The motion carried unanimously.

PLANNING & ZONING

A Public Hearing was opened at 2:05 p.m. for Case File #000-01. A motion was made by Linda Fleming and seconded by Lee Meacham to table the case file until a later date. The motion carried unanimously.

COUNTY VEHICLE INSURANCE

The Commissioners requested that a letter be written to all County entities stating that, because of vehicle insurance stipulations, only County employees may drive County vehicles.

EXTENSION OFFICE

Doug Reynolds of the Cooperative Extension Office advised the Commissioners that its grant for computers to allow disabled individuals to access the internet is now completed. He reported that the Extension Office would like to keep the computers. He also stated that County Library is sending patrons to their office to use the computers for information not available at the Library. The Extension Office has welcomed such usage and has established a usage policy.

SARATOGA FIRE DEPARTMENT

Gary Steele and Don Herold of the Saratoga Fire Department approached the Commissioners with a plan to expand the current Saratoga fire building. They are applying for a \$65,000.00, 50% grant for the

project, but requested funds of \$10,000.00 from the County toward the match. The Saratoga Fire Department does store County fire equipment.

A motion was made by Linda Fleming and seconded by Lee Meacham to participate in the Saratoga Fire Department request to build an additional fire building by providing funds in the amount of \$10,000.00 toward the match. The motion carried unanimously.

CARBON BUILDING

Patty Schuler, Carbon Building Administrator, reported on the status of offices at the building. The Wyoming Drivers License Bureau moved out of its offices in October and are requesting refund of their pre-paid rent. Best Beginnings has requested the vacated office space and will move from the third floor offices it holds now as soon as renovations are completed. Authorization from the Commissioners was given to refund the pre-paid rent to WYDOT, and for Best Beginnings move.

ROAD & BRIDGE

Andy Long of WYDOT briefed the Commissioners on the Brush Creek/Highway 130 project.

Bill Nation, Carbon County Road & Bridge, presented his bi-monthly report.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Bill Nation to solicit bids for the seven miles of upgrade on the Dad/Wamsutter Road, using SC funds. The motion carried unanimously.


ADJOURNMENT
