#### MINUTES

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the minutes of the meetings of February 1, 2000 and February 2, 2000. The motion carried unanimously.

#### INTERMOUNTAIN BENEFIT ADMINISTRATORS

Dale Lyman of IBA, administrators of the County's insurance program, presented the quarterly report to the Commissioners.

#### AUDIT REPORT

Dennis Tschacher presented the Commissioners with the final audit report from Simonsen Mader Tschacher Company, which stated that the County was compliant in all provisions of law and was given a clean audit as of June 30, 1999.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the audit and financial report as submitted by Simonsen Mader Tschacher Company of June 30, 1999. The motion carried unanimously.

#### RUSSELL COMMUNITY PARK

Norman Vigil of the Little Snake River Lions Club, and Rhonda Nicholas of the Little Snake River Events Center presented the Commissioners with a policy for liability coverage for the Russell Community Park. The Events Center and Lions Club will be co-applicants and each organization will split the cost. The County will be listed as additional insured on the policy.

#### SARATOGA FIRE DEPARTMENT

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign a letter of commitment in the amount of \$10,000.00 toward the Saratoga Fire Station project grant. The motion carried unanimously.

#### PLANNING & ZONING

Jonathan Schnal, Carbon County Planning Director, brought a plat before the Commissioners for signatures for a small parcel of land near the Recreation Center that was annexed by the City of Rawlins.

A motion was made by Linda Fleming and seconded by Lee Meacham to sign the plat for the ball fields annexation by the City of Rawlins. The motion carried unanimously.

The Commissioners approved personnel paperwork for Linda Lawrence, the new assistant in the Planning office.

#### ROAD & BRIDGE

Bill Nation gave his bi-monthly report to the Commissioners.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Bill Nation to sign agreements on behalf of Carbon County involving Road & Bridge projects for calendar year 2000. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve Change Order #1 693 691 for WYDOT to Carbon County on the Hanna Connector Road. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to sign an agreement regarding the Snowy Range Road and accepting the Highway 130 realignment. The motion carried unanimously.

#### PUBLIC COMMENTS

Bonnie Culver of the Medicine Bow Senior Center requested remodeling for convenience at the Center. The Commissioners agreed to discuss the projects with Bill Michie, Senior Center Director, at the next Commissioners meeting.

Ben Culver, representing the Medicine Bow Medical Clinic reported that, since the bids for the roof repairs to the building were received last fall, the weather has prevented the completion of the project. Because of the delays, bids will again need to be solicited. The Commissioners agreed that the Clerk's Office would handle the request for bids.

Monty Lauer of the Local Government Liability Pool explained to those present who are currently on the County's health insurance plan why the premiums were increased last year. There had not been an increase in the premiums for several years, and the Commissioners were required to take action to cover rising medical costs.

#### CLERK

A motion was made by Linda Fleming and seconded by Lee Meacham to re-appoint Robert Golden to the Dixon Airport Board, with a term expiration of January 2005. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to re-appoint Steve Hone to the Urban Systems Board, with a term expiration of January 2003. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to re-appoint William Speer to the Planning and Development Commission, with a term expiration of December 2003. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve Draft Request No. 0004 in the amount of \$30, 195.00 to the State Loan and Investment Board for the McFadden Fire Station. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to award the remodeling of Judge Waldrip's offices in County Court to Shepherd Construction for \$7658.00. The motion carried unanimously.



