SHERIFF'S OFFICE BID OPENING

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the bid for the radio console as made by Ryan Electronics, Saratoga, Wyoming for \$16,764.59. The motion carried unanimously.

CLERK

A motion was made by Lee Meacham and seconded by Linda Fleming to allow the Chairman to sign the Cooperative Agreement between the Urban Transportation Systems, the City of Rawlins and Carbon County. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to allow the Chairman to sign the Agreement for Mutual Aid in Emergencies and Disasters between Natrona and Carbon Counties. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to enter into a letter of understanding for engagement with Mader, Tschacher and Peterson for audit services for the fiscal year 1999-2000. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the Change Order #1 in the amount of \$5,650.00 on the courthouse roof from B&M Roofing. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to appoint Carl Baxter to the Dixon Airport Board for a term ending 1-02. The motion carried unanimously.

LONG & ASSOCIATES

A contingency from Long and Associates presented a proposal, as requested by the Commissioners at the last meeting, to provide maintenance for buildings throughout the County. The Commissioners took the proposal under advisement.

WYDOT

Andy Long and Jay Gould from Wyoming Department of Transportation informed the Commissioners that the State is setting up a County Road Improvement Program. Mr. Gould briefly explained the program to the Commissioners RYAN PARK EMS

Homer Beech and Willy Stolns of the Ryan Park EMS requested approval to continue with their request for an ambulance to be donated by the Town of Saratoga as discussed at the last Commissioners meeting. The Commissioners granted that approval.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept from the Town of Saratoga the donation of a 1986 Ford E 350 Econoline 4x2 ambulance to be used as a first responder for Ryan Park EMS assigned to the Carbon County Fire Department. The motion carried unanimously.

PLANNING & ZONING

Jonathan Schnal and Sonya Collamer presented the Proposed Zoning Resolution manual to the Commissioners. Four public meetings will be held throughout the County to allow comment. The Proposal would then be approved by the Commissioners at a later date.

A motion was made by Linda Fleming and seconded by Lee Meacham to set a public hearing for 2 p.m. on July 25, 2000 for the proposed Zoning Resolution changes. The motion carried unanimously.

Bill Nation presented his bi-monthly report to the Commissioners.
