Dennis Tschacher of Mader, Tschacher and Peterson reported to the Commissioners that Carbon County received a clean financial audit for fiscal year 1999-2000.

#### LONG AND ASSOCIATES

Dave Kenik of Long and Associates reported on progress his company has made throughout the County buildings in heating/air maintenance.

#### ROAD & BRIDGE

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize the Chairman to sign an amendment modifying the scope of the contract for planning of Phase III of the Seminoe Dam Road Project. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to enter into agreement for consulting services with PMPC Consulting Engineers for designing Phase IV of the Seminoe Dam Road Project in an amount not to exceed \$350,000.00. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Chairman Zeiger to sign the Cooperative Agreement For The Right-Of-Way Acquisition, Utility Adjustments and Construction for Phase III of the Seminoe Dam Road Project between Carbon County and the Wyoming Department of Transportation. The motion carried unanimously.

Bill Nation presented his semi-monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Lee Meacham to approve salary increases as requested for the Road & Bridge Department employees submitted by Bill Nation. The motion carried unanimously.

#### CLERK

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the minutes of the January 2, 2001 meeting amending to include that Commissioner Meacham left the meeting at 11:30 a.m. and to include under adjournment that the next meeting begins at 7:00 p.m. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to appoint Jerry Wilson to a five-year term on the Dixon Airport Board. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to appoint Jerry Kraft, Pres Williams and Leo Chapman to four-year terms to the Carbon County Weed and Pest Conservation District. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the publication of the gross salaries for full time employees of Carbon County. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept the proposal of Rawlins Fire Extinguisher Service of Rawlins in the amount of \$9,611.04 for UL300 compliance for Carbon County buildings. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize Chairman Zeiger to sign a lease agreement between the Little Snake River Valley Library and the Wyoming Department of Transportation for use of the building for driver's licensing in the amount of \$360.00 per year. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize Chairman Zeiger to sign vouchers for the Dixon Airport construction in the amounts of \$2,400.00 and \$3,489.00. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to authorize the long-term use of the Armory Building by Dave Parker for youth fast-pitch softball. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to enter into Executive Session for the purpose of discussing potential pending litigation and personnel at 8:41 p.m. The motion carried unanimously. A motion was made by Linda Fleming and seconded by Lee Meacham to come out of Executive Session at 9:08 p.m. The motion carried unanimously.

Being there no further discussion, the meeting was adjourned at 9:10 p.m.
