LITTLE SNAKE RIVER AMBULANCE

Ron Taylor, PA, Noyes Clinic, gave a report to the Commissioners on the ambulance service for the Little Snake River Valley. Mr. Taylor reported that 6 lives have been saved, 60 runs were made and 4 persons were saved from having permanent severe disabilities. He also reported there were 21 EMT's on the LSRV Ambulance crew.

CAPITAL FACILITIES

Commissioner Fleming reported that the capital facilities tax will be paid out in June, 2001 and there would be funds which would be held for one year. The amount of the ambulance funds would be approximately \$15000.00.

PROPANE TANK/TANKER

The following individuals spoke and presented letters of concern to the Commissioners regarding the propane tank and tankers at the residence of

Shawn and Leonard Hall on Highway 70, Baggs: Steve and Barbara Powell, Sue and Ludwig Centa and Diane Brock.

The Commissioners have previously had Carbon County Planning and Zoning check into zoning for the area. The State Fire Marshal visited the site to investigate the propane tanks but not the tankers. The above citizens have grave concerns about the propane tanks not being properly decommissioned, the smell, and safety of residents close by. The Commissioners requested that the Clerk draft a letter to the State Fire Marshal office expressing a deep concern regarding safety and ask them to revisit the issue.

AG EXTENSION

Warren Crawford appeared before the Commissioners to report that the University of Wyoming was moving on the vacant position for an AG agent. Mr. Crawford advised the commissioners that the extension office needed a vehicle to replace the big truck used at County Fair. The commissioners agreed to allow Mr. Crawford to purchase a trailer for \$2,000 or less.

CLERK:

Appointments

A motion was made by Linda Fleming and seconded by Art Zeiger to re-appoint Dixie Shea of Hanna, Shirley Herold of Baggs, and Gary Reiber of Elk Mountain to the Senior Services Board. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Art Zeiger that the Rawlins appointment to the Senior Services Board be tabled until the full Board of Commissioners meets in Rawlins on April 3, 2001. The motion carried unanimously.

KIDS Building

Linda Smith, County Clerk, advised the Commissioners that a proposal for use of the KIDS Building for a child care center had been received from Cynthia Zamora. After discussion, the Commissioners

requested that Judges Stebner and Waldrup visit with the Commissioners regarding a need for a juvenile shelter or crisis center before advertising for use of the building.

Bonds

Bonds were approved for David Derragon, Rawlins City Clerk/Treasurer and Courtney V. Bohlender, Clerk/Treasurer for the Town of Saratoga.

Judge's Office

The Commissioners consented to have the blinds and carpet replaced in the district Judges office. The amounts of \$5450.00 and \$2240.00 were budgeted in this year's budget.

Public Health

A motion was made by Linda Fleming and seconded by Art Zeiger that the 2001 contract between HIV/AIDS Prevention Program/Wyoming Department of Health, and the County be approved. The motion carried unanimously.

ROAD & BRIDGE/RIGHT OF WAY EASEMENTS

Bill Nation gave his semi-monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Art Zeiger that the Chairman be authorized to sign a Right of Way Easement on County Road #347 with Jacque Robinson Walton and Douglas or Laura Tuttle, and the Wyoming Game and Fish Commission. The motion carried unanimously.

The easement covers a portion of Section 35, Township 21N, Range 85W 6th P.M. Carbon County, Wyoming.

A motion was made by Linda Fleming and seconded by Art Zeiger that a Right of Way Easement for Carbon County Road 351, for Phase III of the Seminole Dam road project (No. 6-59) be approved. The motion carried unanimously. Commissioner Fleming requested that Commissioner Meacham also sign the easement.

CHEROKEE ROAD

A motion was made by Linda Fleming and seconded by Art Zeiger that the Road & Bridge Department proceed to draft a map and hold a public meeting on the Cherokee Road project. The motion carried unanimously.

BUILDING & GROUNDS

The Commissioners received a proposal for lawn care at the County parks north of the Senior Center and Carbon Building. The Commissioners instructed the County Clerk to advertise for interested parties for the grounds care at the parks. The Commissioners will take under advisement whether to add the Courthouse lawn to the advertisement.

WILDLAND FIRE CONTROL AGREEMENT

A motion was made by Linda Fleming and seconded by Art Zeiger that the 2001 Wildland Fire Control Annual Operating Plan for Carbon County between USDI Bureau of Land Management (BLM) and Wyoming State Forestry Division (WSFD), USDA Forest Service (USFS) and Carbon County be approved. The motion carried unanimously.


Minutes of March 6, 2001 were held for the April 3, 2001 meeting.
