#### CLERK

A motion was made by Lee Meacham and seconded by Linda Fleming to appoint Hollice Hoffman to the Old Pen Joint Powers Board for a three-year term. The motion carried unanimously.

A motion was made by Linda Fleming and seconded by Lee Meacham to accept the agreement between the Tripartite Board and Cynthia K. Zamora for childcare management services at \$1500.00 per month. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept an agreement between Carbon County and Wyoming Association of Risk Management for re-insurance for the County. The motion carried unanimously.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept an application to Federal Emergency Management Agency. The motion carried unanimously.

#### JAIL COMMITTEE

Jerry Colson updated the Commissioners on the preliminary proposals for needs assessment and architectural programming for the jail. The Committee recommended Voorhis and Associates, Inc. for the assessment and programming.

A motion was made by Linda Fleming and seconded by Artlin Zeiger to accept the proposal from Voorhis and Associates, Inc. for the needs assessment and architectural programming for the jail in the amount of \$55,046.50. The motion carried unanimously.

#### EXECUTIVE SESSION

A motion was made by Lee Meacham and seconded by Linda Fleming to go into Executive Session for the purpose of discussing personnel at 10:35 a.m. The motion carried unanimously. A motion was made by Lee Meacham and seconded by Linda Fleming to come out of Executive Session at 11:20 a.m. The motion carried unanimously.

Bill Nation presented his semi-monthly report to the Commissioners.

#### BUDGET PRESENTATIONS

Beginning at 2:00 p.m., budget presentations were heard by the Commissioners from Carbon County Predatory Animal Control Board, Rawlins-Carbon County Airport Board, and C.O.V.E.

Western Wyoming Family Planning, Medicine Bow Clinic, Carbon County Child Development and the Carbon County Counseling Center presented their budget proposals at 3:00 p.m., followed by Wee Folks Place, the Carbon County Chamber of Commerce, the Downtown Development Authority and the Memorial Hospital of Carbon County at 4:00 p.m.

A motion was made by Linda Fleming and seconded by Lee Meacham to support the grant for the Community Based In-Home Services in the amount of \$6,632.00. The motion carried unanimously.


