A motion was made by Lee Meacham and seconded by Linda Fleming to accept the bid for lawn care for the park north of the Senior Center, and north of the Carbon Building from Phyllis McCann in the amount of \$550.00 per month. Lee Meacham and Artlin Zeiger voted for, Linda Fleming voted against the motion. The motion carried.

A motion was made by Lee Meacham and seconded by Linda Fleming to accept a proposal from Leonard Cruz in the amount of \$1100.00 to spring clean the courthouse lawn. The motion carried unanimously.

County Clerk Linda Smith presented the Commissioners with the tentative budget for the 2001-2002 fiscal year.

Gary Graalman withdrew a Resolution for support of fiber optics in Carbon County for consideration at a later date.

#### ROAD & BRIDGE

Bill Nation presented his semi-monthly report to the Commissioners.

A motion was made by Linda Fleming and seconded by Lee Meacham to authorize the Chairman to sign an easement agreement with James Haddenham for road realignment on Road 347. The motion carried unanimously.

The road is more particularly described as: part of the N  $\frac{1}{2}$  NW  $\frac{1}{4}$  lying South of I-80 right-of-way (containing 10.73 acres more or less); NW  $\frac{1}{4}$  (less parts sold) (10.57 acres); Section 35, Township 21, Range 85 (net 116.1 acres more or less); Book 680, Pages 993 & 994, Carbon County, Wyoming.
