The Clerk advised she had received a contract from the State of Wyoming, Office of Community Services for Carbon County to receive \$71,041.00 from the Community Services Block Grant funding for FY 2003. There were no objections from the Commissioners to ratify this grant funding.

Lee Meacham moved to ratify the contract with the Rafters at the Old Armory. Linda Fleming seconded. The motion carried unanimously.

### **Minutes**

Lee Meacham moved to accept the minutes of November 19, 2002 and December 3, 2002, as presented. Linda Fleming seconded. The motion carried unanimously.

### **Appointments**

Linda Fleming moved to appoint Dan Brownell to the Old Penitentiary Joint Powers Board to fill the unexpired term of Mary Apple. Artlin Zeiger seconded. The motion carried unanimously.

Linda Fleming moved to accept with regret the resignations of Mary Belle Lambertsen and William Scoggin from the Carbon County Museum Board. Lee Meacham seconded. The motion carried unanimously.

### **Wyoming Retirement System Update**

Alice Garvin advised the Commissioners that contributions from Carbon County employees for the Wyoming Retirement Board would not be taxed beginning January 1, 2003.

### **Optional Dental Insurance**

Lee Meacham moved to rescind the motion for Carbon County to move the employee optional dental insurance to ReliaStar and remain with the current provider, Wyoming Employees Dental Trust. Linda Fleming seconded. The motion carried unanimously.

### **Carbon County GIS Contract**

Tom Thompson presented the contract with Premier Data Services to the Commissioners after his review. Mr. Thompson advised that Premier Data Services was not willing to incorporate certain changes that Carbon County had previously requested. The Commissioners requested Mr. Thompson contact Premier Data Services and advise them Carbon County is unable to accept the terms of this contract.

Karen Larsen, Carbon County GIS/GPS, requested to meet with the Commissioners and discuss GIS issues.

**PLANNING AND ZONING**

Henry Hewitt came before the Commissioners with Tom Thompson to present certification signed by the Planning Commission to request a public hearing on the amendments to the 1972 Planning and Zoning Regulation with the required 14 days notice, and to take action after the public hearing is completed.

Linda Fleming moved to accept the Certification of Recommendation of the Carbon County Planning Commission in regard to the proposed 2003 Zoning Resolution. Lee Meacham seconded. The motion carried unanimously.

Lee Meacham moved to publish that a public hearing will be held on January 8, 2003 at 9:00 a.m. before the Carbon County Commissioners. Linda Fleming seconded. The motion carried unanimously.

Henry Hewitt introduced Ed Griebel from Anadarco and advised that Anardarco was locating a new field office in Rawlins.

**ROAD & BRIDGE**

Bill Nation presented his bi-monthly report to the Commissioners.

**STATE PARKS AND HISTORIC SITES**

Bill Gentle of Wyoming State Parks and Historic Sites came before the Commissioners to discuss Phase IV of the Seminoe Dam Road #351. He advised that their agency would contribute \$45,000 for the road project, and that this project was not a high priority for them at this time.

Linda Fleming advised that Carbon County would prefer to play a smaller role in this road project due to the fact that this is not a County road and not assume so much responsibility in the project. After some discussion, Mr. Gentle advised that it would be best to leave this project as it stands now until a later time.

Mr. Gentle thanked the Commissioners for Carbon County's assistance in upgrading the Fort Steele Historic area. He further advised that their agency does have funding to stabilize the Settlers Store at the site.

**EXECUTIVE SESSION**

Lee Meacham moved to go into executive session to discuss personnel issues at 9:20 p.m. Linda Fleming seconded. The motion carried unanimously.

Linda Fleming moved to come out of executive session at 9:30 p.m. Lee Meacham seconded. The motion carried unanimously.

**GRANT FUNDED POSITIONS**

Linda Fleming moved that any grant program that will include personnel and County benefits the employee shall be notified, in writing, that the position is an at-will employee status, and the employee status will terminate at the end of the funding. Lee Meacham seconded. The motion carried unanimously.

**CHRISTMAS CLOSURE**

The Commissioners will allow all Carbon County Offices to close at 12:00 noon on December 24, 2002 and remain closed all day December 25, 2002 for the Christmas holiday. There will be normal business hours on December 31, 2002.

There being no further business, the meeting was adjourned at 9:42 p.m.
