**CLERK****Minutes of January 8, 2002:**

Commissioner Meacham moved that the minutes of January 8, 2002 be approved and reflect the following amendments:

- The Commissioners did give their approval for the Carbon County Attorney's Office to proceed with the property work needed in their office.
- Chairman Zeiger requested the minutes of January 8, 2002 to reflect under "Wyoming Game & Fish" that he did state if Wyoming was going to put up funding for the Wyoming G&F project, he would like to see other states assist in funding the project too.

Chairman Zeiger seconded. The motion carried unanimously.

Commissioner Meacham moved that Chairman Zeiger be authorized to sign the Order Appointing Independent Counsel in the matter of Stratton Sheep Company vs. Reidy, appointing Daniel T. Massey. Chairman Zeiger seconded. The motion carried unanimously.

**BONDS**

Bond #51949215 from Western Surety Company for Larry L. Hepner of Saratoga for the Saratoga Cemetery District in the amount of \$20,000.00 was signed by Chairman Zeiger.

Bond #7900531299 from Nationwide Mutual Insurance Company for Janet R. B. Herold for the Town of Baggs in the amount of \$50,000.00 was signed by Chairman Zeiger.

Bond #51949249 from Western Surety Company for John Cowdin of Medicine Bow for the Medicine Bow Conservation District in the amount of \$10,000.00 was signed by Chairman Zeiger.

Bond #53918861 from Western Surety Company for William W. Ball of Rawlins for the County of Carbon in the amount of \$1,000.00 was signed by Chairman Zeiger.

The County Clerk, Linda Ann Smith, advised the Commissioners on the following items:

- The monthly statement of fees for the Carbon County Clerk's Office was \$9,957.00 for December 2001.
- A letter will be sent to the Office of Federal Land Policy notifying them that Carbon County will enter into a cooperating agency status with them. This will provide Carbon County the opportunity to receive input from the public and forward it directly to the state.
- Ken Randolph and John Lawson from the Bureau of Reclamation are scheduled to attend the next Commissioners' meeting on February 5, 2002 at 10:30 a.m. in regard to the Seminoe Dam Road.
- The auditor will be here on February 5, 2002. This is the third clean audit since the Clerk has been in office.
- Carbon County has applied for a grant in the amount of \$250,000 for the design of the detention center / new jail project.
- Karen Jones from Carbon County C.O.V.E. is requesting a letter of support from the Carbon County Commissioners to include with C.O.V.E.'s grant information packet being submitted to the state.

#### ROAD AND BRIDGE

Bill Nation appeared before the Board and presented his bi-monthly report.

Bill Nation requested an authorization letter from the Board of Carbon County Commissioners allowing him to conduct road business on behalf of Carbon County Road and Bridge with the Wyoming Department of Transportation. Chairman Zeiger and Commissioner Meacham signed the authorization letter.

Commissioner Meacham moved that Carbon County enter into a lease agreement with Jim Wiant at \$500 per year and 60 cents per ton thereafter, for gravel permit #425. Chairman Zeiger seconded. The motion carried unanimously.

Bill Nation requested an authorization number to purchase "pit run" gravel at 60 cents per ton, up to 20,000 tons from Jack Zeller for use on parts on C.C.R. #680, 201 and 660, north of Encampment.

Bill Nation requested a clarification for the December 4, 2001 minutes as follows:

"Carbon County Road #351 ends and the Bureau of Reclamation road is called Seminoe Dam Road."

Commissioner Meacham moved to enter executive session at 8:13 p.m. for litigation issues. Chairman Zeiger seconded. The motion carried unanimously.


Commissioner Meacham moved to come out of executive session at 8:18 p.m. Chairman Zeiger seconded. The motion carried unanimously.
