#### CLERK

Linda Ann Smith presented the Monthly Statement of Carbon County Clerk Fees Collected for the month of February 2002 in amount of \$9,217.

Lee Meacham moved to extend the professional services agreement with Voorhis Associates, Inc. for the Needs Assessment and Pre-architectural Programming for the proposed new Carbon County jail to an end date of June 30, 2002 to allow for completion of the scope of services, at no additional cost to Carbon County, second by Linda Fleming. The motion carried.

Linda Fleming moved to accept the disclosure Statement, required by law, of Joy Hannum, Deputy Treasurer of Carbon County, of all interests in any banking institution in Carbon County in which she has money invested, second by Lee Meacham. The motion carried.

Linda Fleming moved that David C. Clark be appointed by the Board of Carbon County Commissioners as an independent Hearing Officer in the matter of the Application of Stratton Sheep Company as Applicant versus Terence M. Reidy and Maureen T. (Ripple) Reidy, Respondents, Docket No. CCR-01-001, and that the Order be signed by the Chairman, second by Lee Meacham. The motion carried.

Linda Fleming moved that the Sheriff be allowed to pursue the Juvenile Accountability Incentive Block Grant award allocation for Carbon County provided through the US Department of Justice, Office of Juvenile Justice and Delinquency Prevention, administered by the Department of Family Services and State Advisory Council on Juvenile Justice in amount of \$14,944 with a County match of \$1,660.44, second by Lee Meacham. The motion carried.

#### CAPITAL FACILITIES TAX (Todd Bishop and Irene Archibald)

The County Clerk advised the Commissioners that Todd Bishop and Irene Archibald were unable to attend the meeting, but have requested that they be allocated time on the April 16, 2002 Commissioner Meeting Agenda. Ms. Smith further said that a packet of information is available for the Commissioners to read prior to the April 16 meeting. Artlin Zeiger said that he would appreciate receipt of a packet prior to the April 16 meeting.

#### CBSA INSURANCE

Dale Lyman, representing Intermountain Benefit Administrators and Corporate Benefit Services of America (CBSA), gave a report to the Commissioners on the current status of Carbon County's self-funded health insurance program. Mr. Lyman reported that the plan is currently within the funded boundaries but cautioned that the prescription drugs category is very high, 27.7 percent of the total amount expended.

#### ROAD & BRIDGE

Bill Nation thanked Gary Steele for attending this meeting. Mr. Nation presented his bi-monthly report to the Commissioners. He gave an update on the North Hanna Access Road advising that only two signatures are needed on land easements for this project to go to bid. One signature, needed from the railroad, pursued by Gary Steele, has been approved. Another is needed from a 1/72<sup>nd</sup> interest trust group representing a deceased land owner that is being pursued by Bart Evans.

Superintendent Nation reported:

- A large number of people in this county are selling and shipping cattle because of an expectation of drought. He reported that the Road & Bridge Department, after the school bus road priority, clears the roads to make sure the cattle trucks can get out;
- Requested authorization for Pepper Tank in an amount up to \$58,500 for pipe and rail to build cattle guards;
- Requested authorization for Dudley Oil, Inc. in amount of \$4,945/each for two (2) oil burner/heaters, Model 200, for the Dixon and Medicine Bow shops.
- Requested a 1995 Chevrolet truck Unit 4011 be declared surplus property. This truck was declared "totaled" because of an accident on March 3, 2002.


