Noyes Clinic

The Commissioners authorized the County Clerk to have inspections conducted of the building proposed for the new Noyes Health Clinic in Baggs and submit the inspection report during the March 18, 2003 meeting.

KIDS Building

Based on previous action taken by the Board of County Commissioners, they executed an Agreement with the Rawlins Mennonite Church for the Church to purchase the old KIDS building. Tom Thompson advised that the closing date is set for May 1, 2003.

SENIOR SERVICES

Bill Michie presented his monthly report to the Commissioners.

County Zoning Enforcement Agent

Linda Fleming moved that Chairman Zeiger be authorized to sign Resolution 2003-10, appointing Dave Clark as the County Zoning Enforcement Agent. Chairman Zeiger seconded. The motion carried unanimously.

RESOLUTION 2003-10

WHEREAS, pursuant to the Zoning Resolution of 1972 Carbon County, Wyoming Section 522 County Zoning Enforcement Agent and Chapter V 500. Regulations h) of the Zoning Resolution of 2003 approved by the Carbon County Commissioners by and through the Carbon County Planning and Zoning board shall appoint a County zoning enforcement agent for the administration and enforcement of the provisions of the Resolution.

IT IS THEREFORE RESOLVED that David C. Clark, County Attorney or his designee be appointed to the position of County zoning and enforcement agent for the purpose of enforcing the zoning resolution. Further, upon reasonable cause or questions to proper compliance, to revoke any Zoning Permit and issue cease and desist order requiring the cessation of any building, moving, alteration or use which is in violation of the provisions of this Resolution.

Long Distance Phone Service

Linda Fleming moved that Carbon County change the telephone long distance service carrier to USP Communications. Chairman Zeiger seconded. The motion carried unanimously.

JAIL COMMITTEE

Lt. Shinkle and Sheriff Colson presented the Jail Committee's report. Sheriff Colson reported that the Committee held meetings in Encampment, Medicine Bow and Elk Mountain and received very positive response. Brochures are currently being finalized for mailing and a jail model is on display at Community First National Bank for public viewing until March 5, 2003.

EMERGENCY MANAGEMENT

Greg Zabel presented his monthly report to the Commissioners. He advised that he has received a request for contracts to provide mutual aid to neighboring counties. Mr. Zabel requested Tom Thompson review the request and mutual aid agreement.

GIS / GPS

Karen Larsen, GIS Specialists presented her monthly report to the Commissioners. She advised that she should receive data from Premier Data in the next few weeks.

Ms. Larsen advised the Commissioners that she will be attending an ARC map training class in Jerome, Idaho on March 20 and 21 and a computer software class in Boulder, Colorado during April 2, 3, 4, 2003.

ROAD AND BRIDGE

Bill Nation introduced Bert McCauley from Federal Highway Administration, and Tim Morawski and Penny Walters from Medicine Bow National Forest Service of Saratoga.

Mr. Nation advised that Carbon County is invited to become a "cooperator" on a plan to improve the South Highway. The Plan is sponsored by the Forest Highway Program and includes 10 miles of Hwy. 71, 34 miles of Carbon County Road 401, concluding at the terminus of Hwy. 70, with approximately 10 miles of forest road.

The initial improvement would be covered one hundred percent by federal funding, but an agreement would need to be in place with a "cooperator" to maintain the road before federal funds would be expended. The "cooperator" would be responsible for maintaining the road once complete, furnish the right-of-way, and move any utilities if needed.

Commissioner Fleming suggested that community meetings be held to gather input from the citizens regarding acceptance of approximately 10 miles of forest road as part of a county sponsored project. Mr. McCauley advised that if Carbon County did decide to become a "cooperator," the Federal Highway Administration would map the area and hold community meetings prior to beginning a project. A meeting concerning the proposed project will be held in Cheyenne on March 26, 2003.

Seminole Dam Road Agreement

Linda Fleming moved that the Chairman be authorized to sign Amendment No. 2 to Owner Engineer Agreement for Seminole Dam Road - Phase 4, Project No. CRF6-58. Chairman Zeiger seconded. The motion carried unanimously.

CONSTRUCTION MANAGER AT RISK INTERVIEWS

The following construction companies were interviewed by the Commissioners and the Jail Committee based on their proposals for the Construction Manager At-Risk position for the new Carbon County Jail.

1. LM Olson Construction
2. Contractors NW
3. Groathouse Construction

FOUR-WHEELER RACE

Jack Morgan, on behalf of the Rawlins Chamber of Commerce Tourism Board, requested permission to use Carbon County property located on the corner of Harshman and Daley Streets for a four-wheeler race to be held on March 15 and 16, 2003. Mr. Morgan told the Commissioners that the Fair Board had approved use of the fairgrounds property for the event and if the County property could be used a race track could start on the fairgrounds, move across Harshman Street and end back at the fairgrounds.

Commissioner Fleming requested that Mr. Morgan submit a detailed plan of all activities included in the event, in writing, to the County Clerk, Linda Ann Smith, by Thursday, March 5, 2003. He must also provide a copy of the Rawlins Chamber of Commerce's liability insurance information. Mr. Morgan was also advised that the Carbon County Attorney must approve the waivers for this event.

EXECUTIVE SESSION

Linda Fleming moved to go into executive session to discuss personnel issues at 5:40 p.m. Chairman Zeiger seconded. The motion carried unanimously.

Linda Fleming moved to come out of executive session at 6:30 p.m. Chairman Zeiger seconded. The motion carried unanimously.

Linda Fleming moved to award the contract for Construction Manager At Risk to L. M. Olson Construction provided that the jail committee along with Charlie VanOver of Plan One successfully negotiate the contract with Olson Construction, second by Chairman Zeiger. The motion carried unanimously.

COUNTY FIRE DEPARTMENT

Commissioners reviewed a report from Dwight France, County Fire Warden.

Commissioners require clarification of the contract for the \$51,905 FEMA grant awarded to the Carbon County Fire Department as to the time lines of the date of purchase of fire fighters personal protective gear and portable radios.

The following items were requested with funding from Strike Team funds:

- The Commissioners approved the use of \$3,310 to purchase tires for a military 5-ton truck.
- The Commissioners approved the Strike Team reimburse \$10,000 to the Hanna Fire Department to help with the debt on the new Hanna water tender.
- A bid was received from Fremont Motors for a 2003 diesel pick-up in the amount of \$28,543.10. The Commissioners took the bid under advisement.
- Mr. France requested to use the remaining Strike Team funds to assist in purchasing a new water tender, as the entire fleet is over 20 years old. The Commissioners took the matter under advisement for the upcoming budget.
- Mr. France requested to give \$10,000 to the Encampment Fire Department to assist them in building a new fire station. The Commissioners wanted to do more research into the project with regard to previous funding.

The Commissioners approved the Fire Warden's request to raise the pay rate for trained firefighters from \$7.50 to \$10.00 per hour, and the pay rate from \$12.00 to \$14.00 per hour if they hold a Firefighter 1 certification.

Chairman Zeiger adjourned the meeting at 6:45 p.m.
