CLERK

Courthouse Heating and Air Conditioning

Clerk Smith invited the Board to a walkthrough with herself and Long Building Technologies, September 7, 2005 at 9:00 a.m. to review the Courthouse heating and air conditioning project.

Minutes

Commissioner Weickum moved to approve the minutes from the August 16, 2005 Commissioners meeting as presented. Commissioner Meacham seconded and the motion carried unanimously.

Forest Reserve Funding

Clerk Smith presented an updated resolution for Forest Reserve Funds that the county receives.

The Board executed a letter to the Governor stating the county's intent to elect to choose the full payment option for Forest Reserve Funds.

Commissioner Meacham moved to approve Resolution No. 2005-29, A Resolution Electing to Take Full Payment Under Public Law 106-393., H.R. 2389, Secure Rural Schools and Community Self-Determination Act of 2000, Forest Reserve Funds. Commissioner Weickum seconded and the motion carried unanimously.

RESOLUTION NO. 2005-29**A RESOLUTION ELECTING TO TAKE FULL PAYMENT UNDER
PUBLIC LAW 106-393, H.R. 2389, SECURE RURAL SCHOOLS AND COMMUNITY SELF-
DETERMINATION ACT OF 2000, FOREST RESERVE FUNDS**

WHEREAS, legislation has been enacted under Public Law 106-393, known as H.R. 2389, the purpose of which is to distribute timber sale receipts for the benefit of schools, road construction and to communities to establish collaborative restoration, maintenance and stewardship projects; and

WHEREAS, Counties have the option of continuing to receive payments under the 25 Percent Fund Act, or electing to receive its share of the average of the three highest 25 percent payments made to the county during the period of fiscal year 1986 through fiscal year 1999 (the full payment amount); and

WHEREAS, the Board of County Commissioners believe it to be in the best interest of the citizens of Carbon County that the Board elect to take the full payment option under Title III of Public Law, 106-393, H.R. 2389;

THEREFORE BE IT RESOLVED by the governing body of Carbon County, Wyoming that the County elect to receive the full payment option under Title III of such act.

Monthly Receipts

Clerk Smith presented and the Board approved monthly receipts for Road & Bridge in the amount of \$200.00 and for the Clerk's Office in the amount of \$17,988.00.

Conservation District Funding

Clerk Smith presented a letter from Jean Runner, Secretary for the Saratoga Encampment Rawlins Conservation District, requesting the Board sign a letter of support regarding additional funding for local conservation districts.

Commissioner Weickum moved to execute a letter of support to the Wyoming Department of Agriculture concerning additional funding for local conservation districts. Commissioner Meacham seconded and the motion carried unanimously.

LM Olson Retainage

Clerk Smith presented a request from LM Olson to be paid 5% of retainage held on construction of the new jail. She stated that Tom Thompson has reviewed the request and replied that the Board could pay the 5% if it finds that the work is satisfactory and substantially completed, that there is a substantial reason to pay. She also advised the 41-day advertising period is up September 23, 2005.

The Board requested to speak with Sheriff Colson regarding the request.

Liquor License

Clerk Smith stated the incorporation papers for the Arlington Outpost were received and she presented a liquor license for renewal.

Commissioner Meacham moved to approve a County Retail or Special Malt Beverage Permit for the Arlington Outpost for a period of one year ending August 31, 2006. Commissioner Weickum seconded and the motion carried unanimously.

Dixon Airport

Commissioner Weickum moved to authorize the Chairman to sign the Request for State Airport Aid from the State of Wyoming in the amount of \$433,710.00 for the Dixon Airport runway extension project. Commissioner Meacham seconded and the motion carried unanimously.

Commissioner Weickum moved to ratify the signatures of August 22, 2005 on the Agency Agreement Federal Aid Project NO. 3-56-0038-08 State Project NO. 9U4, State Grant No. Rehab Runway 16/34, regarding runway extension at the Dixon Airport. Commissioner Meacham seconded and the motion carried unanimously.

Project Prevention

Commissioner Weickum moved to authorize the Chairman to sign the Contract Monthly/Quarterly Expenditures Report Form and Invoice for Wyoming Prevention Federal Block Grant, Project Prevention/Carbon County 341-1073 in the amount of \$6,000.00 for expenditures from January 2005 through June 30, 2005. Commissioner Meacham seconded and the motion carried unanimously.

Telecommunications Lease

Commissioner Meacham moved to approve the lease documents with Bank of the West, Lease Agreement No. 002-0001573-001, including the Request to Disburse Proceeds, Essential Use Letter, Resolution No. 2005-30, a Resolution of the Governing Body, Request to Disperse Funds, Certificate of Acceptance, and Amendment to the Lease Agreement, all related to the lease for the telecommunications system with Bank of the West. Commissioner Weickum seconded and the motion carried unanimously.

**RESOLUTION OF GOVERNING BODY
EXTRACT OF MINUTES**

LESSEE: Carbon County

LESSOR: Bank of the West

DATE OF EQUIPMENT LEASE AGREEMENT:

At a duly called meeting of the governing body of Lessee (as defined in the Equipment Lease Agreement) held on the 6th day of September 2005 the following resolution was introduced and adopted.

WHEREAS, the governing body of Lessee has determined that a true and very real need exists for the acquisition of the Equipment described in the Equipment Lease Agreement presented to this meeting; and

WHEREAS, the governing body of the Lessee has taken the necessary steps, including any legal bidding requirements, under applicable law to arrange for the acquisition of such Equipment.

BE IT RESOLVED, by the governing body of Lessee that the terms of said Equipment Lease Agreement are in the best interest of the Lessee for the acquisition of such Equipment, and the governing body of Lessee designates and confirms that the persons indicated below are authorized to execute and deliver the Equipment Lease Agreement and any related documents necessary to the consummation of the transactions contemplated by the Equipment Lease Agreement.

FURTHER BE IT RESOLVED, that pursuant to Section 265 (b) 3 (D) of the Internal Revenue Code, as amended, the governing body of Lessee hereby designates this Equipment Lease Agreement as comprising a portion of the \$10 million in aggregate issues designated as "qualified tax-exempt obligation" eligible for the exception to the general rule of the Code which provides for a total disallowance of a deduction for interest expense allocable to the carrying of tax-exempt obligations. The governing body of the Lessee further certifies that it does not reasonably contemplate issuing more than \$10,000,000 of "qualified tax-exempt obligations", as defined in the Code, during 2005.

Clerk Smith stated there is a \$550.00 payment due to Bank of the West for closing on the lease.

Board Appointment

Commissioner Meacham moved to reappoint Ransom Hackett to the Baggs Solid Waste Disposal District for a term of three years ending September 2008. Commissioner Weickum seconded and the motion carried unanimously.

ELECTED OFFICIALS

Sheriff

Jerry Colson requested and received authorization to purchase an additional monitor in the amount of \$375.67 for the new Courthouse security system.

Sheriff Colson stated Tom Thompson advised him to display notices at the Courthouse stating there are security cameras in place. The Board agreed and authorized Sheriff Colson to do so.

Treasurer

Cindy Baldwin stated she recently attended an Interim Revenue Committee meeting where it was decided to present legislation to raise the cap on severance and mineral royalties. Ms. Baldwin stated this would increase the amount dispersed to counties and to the Department of Transportation for road construction.

Ms. Baldwin also reported that tax notices are being sent and the county should collect approximately \$41 million, a \$7 million increase from last year.

Clerk of District Court

Lindy Schmidt, Clerk of District Court, presented contracts between the county and attorneys acting as Guardians Ad Litem.

Ms. Schmidt stated that a local construction company requested written specifications be presented so they may prepare a construction bid for the Clerk of District Court office. Ms. Schmidt requested direction on how to proceed.

Clerk Smith stated rather than preparing specifications, Ms. Schmidt could prepare and advertise Request for Proposals and any interested parties could then discuss with Lindy the work to be performed.

Commissioner Meacham moved to authorize the Chairman to sign Professional Services Contracts between the County and John L. Hoke, Cindy L. Delancey, P.M. Roberts, Dan Massey, John DeLeon, and William Curley for Guardian Ad Litem services, all for periods of six months ending December 31, 2005 and in the amount of \$90.00 per hour. Commissioner Weickum seconded and the motion carried unanimously.

Ms. Schmidt stated she will send the Contracts to the State so the county can be reimbursed for a portion of these fees.

SENIOR SERVICES

Terri Archer reported that election of officers for the Senior Services Board will be held in October. Ms. Archer will be advertising for a new site manager and cook for the Encampment area, as the current manager will be retiring soon.

Ms. Archer stated the lift on the handicapped accessible bus needs modification to accommodate clients in wheelchairs. She stated there is a six-inch gap between the ground and the lift requiring clients to be lifted onto the lift. The Board asked Ms. Archer to look into the possibility of having an inclined ramp built to attach to the lift so employees would not have to lift clients.

Commissioner Weickum offered to take the van to find someone to modify the lift.

COVE

Karen Lebeda reported that C.O.V.E. has completed a \$25,000.00 grant application to the Wyoming Business Council for a planning grant for a proposed facility to incorporate COVE and Substance Abuse Task Force offices, and low to moderate income day care and educational services.

Ms. Lebeda stated that a cash match of 25% is required and requested the county provide \$2,500.00 of the match.

Tom Johnson of the Wyoming Business Council further explained the application and stated it appears to meet all the application requirements and expects the application will be funded. Mr. Johnson also stated a potential for future grant funding for the project.

Cindy Baldwin, County Treasurer and COVE Board Member, stated her support and recommended approval of the \$2,500.00 match, as did Terri Sisneros, DeShann Schinkel, and Deb Allen.

Commissioner Weickum moved to support a Wyoming Business Council Planning Only Grant Application submitted by COVE and allot \$2,500.00 from Special Project Funding for a cash match. Commissioner Meacham seconded and the motion carried unanimously.

CITY OF RAWLINS

Deb Allen and DeShann Schinkel of the City of Rawlins and Tom Johnson of the Wyoming Business Council discussed economic development strategies for the county and offered their assistance on any grants and partnering for projects.

Mr. Johnson stated he covers four Wyoming counties, including Carbon County, for the Business Council and hopes to soon be hiring one or two deputy directors and possibly place one full-time in Carbon County to help with grants and projects.

ECONOMIC DEVELOPMENT CORPORATION

Harry Lovato, Economic Development Corporation (EDC) Director, stated that the EDC allotted \$2,500.00 towards a match for the fiber optic feasibility project and he expects the EDC could allot additional funding to help cover part of additional funds that would be needed for the study.

Mr. Lovato stated EDC met last week and will donate funding to non-profit groups to buy Carbon Mercantile stock.

The Board asked Mr. Lovato and Mr. Johnson of the Wyoming Business Council how they feel the best way to proceed with an economic development group would be. Mr. Johnson stated he feels that using the 501(c)6 status of the current EDC but change the name would be best. Mr. Lovato stated he would approve a group using the non-profit status of the current EDC and forming a new board of directors but does not feel the name needs to be changed.

Mr. Lovato stated the by-laws of the EDC state the County Commissioners may have three representatives on the EDC. One will be a Commissioner and two can be appointed at-large and must reside in Carbon County. He added that each municipality within the county may have one representative. There is a meeting on September 29, 2005 where Mr. Lovato stated these members may appear and request the EDC remain active, and the process of electing a new board of directors could begin.

The Board agreed to attend the September 29th EDC meeting and Mr. Lovato agreed to invite a representative from each municipality to attend.

PERFORMAX

Dale Lyman overviewed the County's insurance and prescription plans and explained savings and expenses for the period of October 1, 2005 through August 31, 2005. Mr. Lyman also presented a comparison of the county's plan to other plans. Mr. Lyman also presented three Reinsurance quotes.

Commissioner Meacham moved to use a specific level of \$40,000.00 for reinsurance with Hartford. Commissioner Weickum seconded and the motion carried unanimously.

RECESS

Chairman Zeiger recessed for lunch at 12:27 p.m. and reconvened at 2:00 p.m.

Area Work

Mr. Nation reported that bridge and culvert replacement was completed last week on County Road 412E. Another culvert replacement will be complete this week at Buffalo Gulch on County Road 504. All other areas will be continued to be bladed and school bus routes improved. Improvements are still being made with the help of Anadarko on 20 Mile Road, County Road 605N.

Mr. Nation reported he was recently elected Chairman of the Wyoming T2 Advisory Board for 2006.

Mr. Nation also reported that Seminoe Road (County Road 351) should be 90% complete by fall. Chip sealing, center striping, and other minor work will begin next spring.

LITTLE SNAKE RIVER EMS

Ron Taylor and Alexandra Iversen of the Little Snake River EMS reported they have contacted several oil companies requesting funding for a four-wheel drive ambulance to be used in the Baggs area. Mr. Taylor stated he plans to apply for a grant for half the cost of the ambulance, \$60,000.00, and is requesting \$60,000.00 from the Board for the other half.

Clerk Smith stated there is approximately \$42,000.00 in Forest Reserve Funds the county has not allocated towards any specific project.

Commissioner Meacham moved to allocate \$42,000.00 of Forest Reserve Funds to the Little Snake River EMS towards the purchase of a new four-wheel drive ambulance to be used in the Baggs area. Commissioner Weickum seconded and the motion carried unanimously.

LM OLSON RETAINAGE – NEW JAIL

Sheriff Colson reported he spoke with Randy Shinkle at the new jail regarding incomplete construction items at the new jail.

The Board’s consensus was to wait until the forty-one day advertising period is complete, September 23, 2005, and consider paying the full retainage amount at that time.

MEDICINE BOW CONSERVATION DISTRICT

Todd Heward of the Medicine Bow Conservation District requested a letter of support for additional funding from the Wyoming Department of Agriculture.

The Board stated it signed a letter of support for all county conservation districts earlier today and will provide a copy to Mr. Heward.

Vicki Hitchcock presented one sealed bid for construction at the Medicine Bow Library. The bid from Custom Builders including all material and labor totals \$27,200.00.

Clerk Smith stated there is \$10,000.00 in the budget and \$12,000.00 from Special Projects for the project. Ms. Smith stated the remainder could possibly be taken from Buildings and Grounds.

Commissioner Meacham moved to accept the bid from Custom Builders in the amount of \$27,200.00 for materials and labor at the Medicine Bow Library. Commissioner Weickum seconded and the motion carried unanimously.

The Board directed Ms. Hitchcock and Clerk Smith to communicate regarding funding sources, stating that Ms. Hitchcock could possibly delay other projects and use that funding towards this construction.

EMERGENCY MANAGEMENT

Greg Zabel stated a year ago the Environmental Protection Agency tested the Armory for lead, and has now contracted him stating they have hired a company to abate the lead that was found. Mr. Zabel stated he was informed the armory must shut down for two to four weeks while the lead is abated.

Mr. Zabel also reported the Bureau of Land Management has formed a concrete slab for a wind generator approximately 110 feet from the county's radio towers located at the armory. Mr. Zabel stated his concerns for the generator interrupting the radio transmission. He has contacted Greg Ryan regarding his concerns and recommended Tom Thompson draft a letter to the BLM requesting confirmation the generator will not interfere with transmission.

It was the consensus of the Board that Mr. Zabel contact Tom Thompson to write to the BLM to advise the agency of concerns.

PUBLIC HEALTH

Bridget Hettgar presented a lease agreement with Betty McIlvaine for the Saratoga Public Health Office. Ms. Hettgar stated Tom Thompson has reviewed the agreement and added language.

Ms. Hettgar also presented a bioterrorism contract renewal with the State Department of Health in the amount of \$48,700.00.

Ms. Hettgar reported she has been requested by the Veteran's Administration Hospital to place a camera in the Public Health Office for veterans who need psychological evaluations. This would allow veterans to visit psychologists who are located in other cities. The Veterans Administration will buy all equipment, and provide all maintenance and training of staff.

Commissioner Meacham moved to authorize the Chairman to sign the Memorandum of Understanding Between the Wyoming Department of Health, Community and Family Health, Public Health Nursing, and Carbon County for Public Health Emergency Preparedness for a term of one year ending August 30, 2006. Commissioner Weickum seconded and the motion carried unanimously.

Commissioner Meacham moved to authorize the Chairman to execute a lease agreement with Betty McIlvaine for Saratoga Public Health Office space in the amount of \$500.00 per month, for a period of one year ending August 31, 2006. Commissioner Weickum seconded and the motion carried unanimously.

No action was taken regarding the Veteran's camera.

JUVENILE DETENTION

Commissioner Meacham moved to authorize the Chairman to execute a Provider Agreement with Regional Juvenile Detention Center in the amount of \$124.00 per day per juvenile for juvenile detention. Commissioner Weickum seconded and the motion carried unanimously.

MUDDY GAP FIRE STATION

Clerk Smith stated she has been working with Frank Erickson, Muddy Gap Fire Chief, to install a waterline and a septic tank for a restroom at the Muddy Gap Fire Station. The restroom will require tapping into the Erickson's personal waterline and Ms. Smith would like authorization to move forward with advertising for proposals for the plumbing portion of the project, and to negotiate a lease or memorandum of understanding (MOU) regarding the county's use of the Erickson's water.

The Board authorized Ms. Smith to obtain a lease agreement, have Tom Thompson review it, and present it for approval at a later date.

NOYES HEALTH CARE CENTER

Clerk Smith stated she has been contacted by Linda Fleming regarding the Board's denial of a request from the Noyes Health Care Center to pay for painting supplies used to paint a portion of the Center. Clerk Smith presented the request again and asked the board to reconsider. The Board stated the request should have been made before the supplies were purchased and again denied the request.


FIBER OPTICS PLANNING GRANT

Clerk Smith stated only one proposal was received for a feasibility study to be performed on the fiber optics project. Harvey Economics in Denver, Colorado submitted the proposal in the amount of \$41,965.67. Ms. Smith stated the budget for the project is \$33,333.00, including a \$25,000.00 grant and various matching funds.

Ms. Smith stated the committee will be interviewing the applicant soon and will recommend action in the near future. She also requested authorization to obtain the additional \$8,632.67 from other entities and from the county budget. The Board authorized Ms. Smith to move forward.


