GUARDIAN AD LITEM

Tom Thompson and Wade Waldrip spoke regarding a newly established state-funded program for Guardians Ad Litem (GALs) in abuse, neglect and CHINS cases. The 75% reimbursement program begins July 2005. Mr. Thompson stated the reimbursement would be 75% of a \$75.00 per hour fee with a reimbursement cap of \$60.00 per hour. Mr. Thompson stated he has reviewed the Memorandum of Understanding and recommends its approval.

Judge Waldrip requested the Board increase GALs hourly rates from \$80.00 to \$90.00 stating that beginning in July, any attorney acting as a GAL must undergo five hours of specialized training per year, and that he feels their work is important enough to warrant the increase. Judge Waldrip also recommended approving the MOU.

Commissioner Meacham moved to increase the hourly rate for Guardians Ad Litem from \$80.00 to \$90.00 effective July 1, 2005 and to authorize the Chairman to sign the Memorandum of Understanding Between the Wyoming Supreme Court, the District Judges' Conference and Carbon County; and authorize the Chairman to sign Appendix A, Memorandum of Understanding GAL Fee Schedule Effective July 1, 2005. Commissioner Weickum seconded and the motion carried unanimously.

CHEROKEE ROAD

Tom Thompson stated he spoke with Road & Bridge Superintendent, Bill Nation, regarding the proposed Cherokee Road easement, and they have since had three landowners sign the easement agreement. Mr. Nation will send a letter to the remaining landowners requesting they sign the agreement.




