A regular meeting of the Board of Carbon County Commissioners (BOCC) commenced Tuesday, January 6, 2026, at 9:00 a.m. at the Carbon Building-Courthouse Annex, Rawlins, WY. Attending the meeting were Chairman, R. Travis Moore, Vice Chairman Gwynn Bartlett, Commissioners John Johnson, John Espy and Sue Jones.

Chairman Moore called the meeting to order at 9:00 a.m.

CONSENT AGENDA

Malone, Treasurer for the City of Rawlins in the amount of \$250,000.00, Notice of County Valuation Adjustments in the amount of (\$512,261.00) and a Tax Roll Correction in the amount of (\$326.20). Vice Chairman Bartlett seconded and the motion passed unanimously.

ELECTED OFFICIALS & DEPARTMENT HEADS

Treasurer

County Treasurer, Lindsey West requested the Chairman's signature on Resolution No. 2026-01 Carbon County Investment Policy and to designate depositories for the county.

Vice Chairman Bartlett moved to approve and authorize the Chairman's signature on Resolution No. 2026-01 Carbon County Investment Policy pending legal approval. Commissioner Johnson seconded and the motion passed unanimously.

RESOLUTION NO. 2026-01 CARBON COUNTY INVESTMENT POLICY

WHEREAS, W.S. §9-4-831(h) mandates every political subdivision adopts "a statement of investment policy"; and

WHEREAS, CARBON COUNTY desires to adopt an investment policy at least as restrictive with respect to the types of investment as authorized by W.S. §9-4-831(a), a copy of which is affixed hereto and incorporated herein by this reference.

NOW THEREFORE BE IT RESOLVED BY THE GOVERNING BODY OF CARBON COUNTY, WYOMING:

- (a) The CARBON COUNTY financial accounting procedures are divided among the County Commissioners, the County Clerk and the County Treasurer. The County Clerk is designated as budget officer (W.S. §16-4-102(a)(iv)); the County Treasurer is in charge of the county treasury (W.S. § 18-3-804 and 18-3-805. Warrants for payment from the treasury must be authorized by the Board of County Commissioners (W.S. §18-3-504 and 18-3-805);

- (b) It shall be the policy of the Carbon County Treasurer to invest public funds in a manner which will provide the highest investment return with the maximum security, and conforming to all federal, state and local laws and regulations governing the investment of public funds;
 - (1) To the extent possible, the Carbon County Treasurer will attempt to match its investments with anticipated cash flow requirements. Unless matched to a specific cash flow, the Carbon County Treasurer will not directly invest in securities maturing more than two (2) years from the date of purchase.
 - (2) Funds in excess of cash flow requirements may be invested in securities maturing not more than five (5) years from the date of purchase, if the maturity of such investments is made to coincide as nearly as practicable with the expected use of funds.
- (c) Any person affecting an investment transaction on behalf of CARBON COUNTY, or offering investment advice, shall sign a statement indicating he or she has read this policy and agrees to abide by this policy and by applicable federal, state and local laws, with respect to the advice given and transactions undertaken on behalf of the County.
- (d) The Carbon County Treasurer shall be, and is hereby authorized to make such statutory investments, at his or her discretion, as will conform to this policy which shall be deemed at least as restrictive as the types of investments authorized by W.S. §9-4-831(a).
 - (1) The County shall diversify its instruments by security type and institution. With the exception of U.S. Treasury securities, certificates of deposits and authorized pool, no more than twenty-five percent (25%) of the County's total investment portfolio will be invested in a single security type.
 - (2) To provide assurance that the County will be able to continue financial operations without interruption and dependent upon interest rates and satisfaction with services, the County will generally attempt to utilize at least two financial institutions as depositories.
- (e) Pursuant to Constitutional Amendment A, the Treasurer may invest County funds in equities to the extent and in the manner the legislature may allow by law which is enacted by a two-thirds vote of both houses of the legislature.
- (f) The Treasurer is charged with the responsibility of providing a monthly financial report, to include investment activity and returns, in the County's Financial Report.
- (g) This policy shall be effective through the calendar year 2026.

WHEREFORE, be it resolved that the Board of County Commissioners adopts the aforementioned policy and this policy shall be reviewed on an annual basis.

Sheriff

Alex Bakken, Carbon County Sheriff recognized Classic Air (Intermountain) as the 2025 Community Partner.

Certifications

Kristy Rowan, Planning & Development Coordinator and Zoning Administrator presented a Certification of Recommended Action for Z.C. Case File No. 2026-01 – Calvin and Nancy Stropel.

Vice Chairman Bartlett moved to accept the Certification of Recommended Action from the Carbon County Planning & Zoning Commission for Z.C. Case File No. 2026-01 for Calvin and Nancy Stropel and schedule a public hearing for Tuesday, February 3, 2026, at 11:30 a.m. at the Carbon Building- Courthouse Annex located in Rawlins, Wyoming. Commissioner Espy seconded and the motion passed unanimously.

Road & Bridge

Kandis Fritz, Road & Bridge Coordinator stated that she is still working on compiling information for warranty information for equipment.

Buildings & Grounds

Jeff Askins, Buildings and Grounds Manager provided an update for his department. He is still working on the landscaping bid as well as the corner parking lot pricing.

Public Health

Amanda Brown, Public Health Coordinator, provided an update on her department. She discussed flu season and that cases are increasing in our community. She stated it isn't too late to get a flu vaccine. She discussed the Carbon County Connect Team that supports trauma or tragedy as a community support. They are still working on building the team and plan and she is trying to get the word out.

Attorney

Ashley Davis, Deputy County Civil Attorney, asked the board if they would like to submit a comment letter to Wyoming Department of Environmental Quality for the Section 401 Water Quality Certification Request for the Seminoe Pumped Storage Project.

Commissioner Espy moved to authorize the chairman's signature on a letter to Wyoming Department of Environmental Quality to request a meeting in Carbon County. Commissioner Johnson seconded and the motion passed unanimously.

Commissioner Jones moved to authorize the chairman's signature on a comment letter to Wyoming Department of Environmental Quality for the Section 401 Water Quality Certification Request for the Seminoe Pumped Storage Project. Vice Chairman Bartlett seconded and the motion passed unanimously.

COMMISSIONERS

Commissioner Jones requested the Chairman's signature be ratified on the Services Agreement that was signed on December 19, 2025.

Commissioner Jones moved to ratify the Chairman's signature on the Dixon Airport IFE Services Inc. Agreement for Consultant Services in the amount of \$2,250.00 for the South Apron Land Acquisition Project – Contract Admin., Environmental, Planning, Acquisition Support, Design, Bidding, Construction and Closeout Phase Services. Vice Chairman Bartlett seconded and the motion passed unanimously.

CITIZEN/COMMISSIONERS DISCUSSION

Commissioner Johnson stated they are coming up to the legislative session and suggested the public should educate themselves and reach out to their legislatures.

Vice Chairman Bartlett discussed the monthly meeting with the City of Rawlins and that she will be attending the hospital breakfast meeting tomorrow.

Commissioner Jones discussed the update from the Assessor on exemptions. She has currently \$96,000 in long-term homeowner exemptions. They have until May to sign up. She detailed that this affects schools, special districts and reaches much further than just the county. These dollars go to local government and not to the state.

Commissioner Espy stated that the House of Representatives passed the Speed Act that makes counties cooperating agencies that affect NEPA rule making. He also discussed the Secure Rural Schools funding.

Chairman Moore recently met with the Sheriff and Fire Warden where they discussed communications. They discussed future infrastructure, equipment, and training to have a comprehensive communication plan.

Recess

POWER COMPANY OF WYOMING

Kara Choquette, Vice President, Communications and Government Relations, Roxane Perruso, Kelly Cummins, Amy Groseclose, Grant Gerrard and Ryan Jacobson all with Power Company of Wyoming LLC provided a preliminary overview of the Seminoe Generating Station. This project is a natural-gas fired combustion turbine power plant that will generate approximately 2,000 MW on a 68.5 acre site located on private land that is adjacent to Transwest Express. This project is estimated to have 350 constructions jobs at its peak with more than 30 long term operations jobs.

Commissioner Johnson asked where the water will come from? Ms. Cummins stated this will come from the North Platte River through the ranch's current water rights. This is estimated consumption is 320-acre feet annually. He does applaud them for using the dry cooling system to reduce water usage.

Commissioner Espy asked how many mcf of gas will this consume? There is capacity nearby to handle the requirements. The plan is for the gas plant to come online with Transwest.

JONES SIMKINS

Jason Sleight with Jones Simkins presented the draft Carbon County Financial Statement for Fiscal Year 2025.

EXECUTIVE SESSION

Commissioner Espy moved to go into executive session at 10:40 a.m. with Clerk Smith and Ashley Mayfield Davis to discuss personnel, potential litigation and other matters considered confidential by law. Commissioner Johnson seconded and the motion passed unanimously.

Commissioner Espy moved to come out of executive session at 11:02 a.m. noting no action was taken and that the minutes be signed and sealed. Commissioner Johnson seconded and the motion passed unanimously.

MEMORIAL HOSPITAL OF CARBON COUNTY (MHCC)

Kerry Ashment, Chief Executive Officer, Stephanie Hinkle, Chief Operations Officer and Joy Coulston, Chief Financial Officer for MHCC, presented a monthly update on the operations of the hospital. Ms. Coulston provided financial data for November through the end of the year. She stated they have started a savings account for equipment that is aging. Mr. Ashment stated they are finally starting to function as a normal hospital. Ms. Hinkle discussed the press release that they issued yesterday announcing a partnership with Western Healthcare. Western Healthcare will be in charge of the staffing of physicians. This doesn't affect current hospital staff, including existing physicians. Ms. Hinkle discussed the Strategic Business Plan and its release.

Chairman Moore opened a public hearing at 11:30 a.m. to hear Planning & Zoning Z.C. Case #2025-05 – Zoran & Vesna Vrhovnik’s request for a Zone Change from Ranching, Agriculture and Mining (RAM – 17.1 Acres) and Forestry Production and Seasonal Recreation (FPSR-34.42) to Forestry Production and Seasonal Recreation (FPSR-51.52) on approximately 51.52 acres. The FPSR Zone is intended to be applied to areas of the County in which timber production and seasonally accessible recreation uses are the desirable predominant uses; and is located approximately 6 miles west of Carbon County Road #291 (Hanna/Leo/Kortes Road) near Pathfinder Reservoir. Kristy Rowan, Planning & Development Coordinator and Zoning Administrator presented the case file.

Chairman Moore called for comments for or against the case. There being no comments, Chairman Moore closed the hearing at 11:37 a.m.

Z.C. Case File #2025-05

WHEREAS, pursuant to the Carbon County Zoning Resolution of 2015, as amended, and Wyo. Stat. Ann. §18-5-202(b), the Carbon County Planning and Zoning Commission held a public hearing on Monday, December 1, 2025, which hearing was advertised by public notice at least thirty (30) days prior to said hearing; and

WHEREAS, at the Monday, December 1, 2025, public hearing, the Carbon County Planning and Zoning Commission provided the public the opportunity to comment and the Carbon County Planning and Zoning Commission considered any public comments which were made at said public hearing; and

WHEREAS, at the conclusion of said Monday, December 1, 2025, public hearing, the Carbon County Planning and Zoning Commission voted to certify in writing its recommendation to the Carbon County Board of County Commissioners to adopt the zone change as an amendment to the Carbon County Official Zoning Map for Carbon County, Wyoming; and

WHEREAS, the Carbon County Board of County Commissioners, pursuant to the Carbon County Zoning Resolution of 2015, as amended, and Wyo. Stat. Ann. §18-5-202(c) and after receipt of said certified recommendation of this zoning amendment to the Carbon County Official Zoning Map, advertised by public notice at least 14 days prior to a public hearing to take public

input and comments on the proposed amendment, which said hearing occurred on Tuesday, January 6, 2026; and

WHEREAS, at said public hearing on January 6, 2026, the Carbon County Board of County Commissioners provided the opportunity for the public to comment and for the Carbon County Board of County Commissioners to consider any comments which were made on the proposed amendment; and

WHEREAS, the Carbon County Board of County Commissioners in considering the proposed amendment have also reviewed and considered the Carbon County Comprehensive Land Use Plan, as amended; and the Carbon County Zoning Resolution of 2015, as amended; and

WHEREAS, the Carbon County Board of County Commissioners have determined that the proposed amendment is in general conformance with the Carbon County Comprehensive Land Use Plan, as amended, and that the proposed zone change meets the following applicable criteria of the Carbon County Zoning Resolution of 2015, as amended; and

2026 OFFICIAL PUBLICATION

Lisa Smith, Carbon County Clerk, reiterated the bids received and the prices for each paper.

The Saratoga Sun quoted \$5.00 per column inch for both legal and classified ads with standard display ads for \$8.00 per inch. The Carbon County Comet quoted \$5.40 per column inch for legal, classified and standard display ads. The Rawlins Times quoted \$4.99 per column inch for legal, \$7.50 per column inch for classified ads, and \$8.00 per inch for standard display ads. Each also provided publication days and publication deadlines. All presented their paid subscription numbers for both print and online subscribers as follows: Saratoga Sun has 799 paid print subscriptions and 139 online subscriptions; the Carbon County Comet has 158 paid print subscriptions and 544 online subscriptions; and the Rawlins Times has 535 paid print prescriptions and 34 online subscriptions.

Commissioner Johnson moved to designate the Carbon County Comet as the Carbon County Newspaper of Record (official publication) for a term of one year beginning January 6, 2026, through December 31, 2026 with the option to extend in November at a negotiated cost for an additional year or to terminate at any time, and at a rate of \$5.40 per column inch for legal, classified, and standard ads noting that the bidding process was completed. Commissioner Espy seconded and the motion passed unanimously.

Joshua Wood asked for clarification on the board's decision since the Comet wasn't the lowest bid. Attorney Davis discussed the bid form and the additional information requested and that the board isn't obligated to go with the lowest bid.
