

**MINUTES OF THE BOARD OF
CARBON COUNTY COMMISSIONERS
BUDGET WORKSHOP
Monday, June 27, 2011
County Courthouse, Rawlins, Wyoming**

A budget workshop of the Board of Carbon County Commissioners (BOCC) commenced Monday, June 27, 2011 at the County Courthouse in Rawlins, Wyoming. Attending the meeting were Chairman Terry Weickum; Vice-Chairman Jerry Paxton; County Treasurer Cindy Baldwin; and County Clerk Gwynn Bartlett.

Chairman Weickum called the meeting to order at 9:09 a.m.

BUDGET AMENDMENT FY 2011

Chairman Weickum opened a public hearing at 9:09 a.m. to hear comments on amending the county's fiscal year 2010-2011 budget.

Clerk Bartlett noted that the following budgets will be amended. Library increase of \$116,129.00, Commissioners increase of \$8,087.10, Treasurer increase of \$3,111.64, Courthouse increase of \$13,700.40, Building & Grounds increase of \$11,224.76, Fire increase of \$2,949.45, and Emergency Management increase of \$6,734.39.

Chairman Weickum called for comments and hearing no comments, closed the public hearing at 1:34 p.m.

Commissioner Chapman moved to adopt Resolution 2011-14, FY 2011 Budget Amendment Number One. Commissioner Paxton seconded and the motion carried unanimously.
